## TRADEMARK RELEASE

THIS TRADEMARK RELEASE (this "Release") is made as of December 1, 2011 by THE BANK OF NEW YORK MELLON TRUST COMPANY, N.A. (formerly known as THE BANK OF NEW YORK TRUST COMPANY, N.A.), as Trustee ("Secured Party"), in favor of THE MAJESTIC STAR CASINO, LLC, THE MAJESTIC STAR CASINO CAPITAL CORP., MAJESTIC INVESTOR CAPITAL CORP., MAJESTIC INVESTOR, LLC, MAJESTIC INVESTOR HOLDINGS, LLC, MAJESTIC STAR CASINO CAPITAL CORP. II, BARDEN MISSISSIPPI GAMING LLC, BARDEN COLORADO GAMING, LLC, THE MAJESTIC STAR CASINO II, INC., BUFFINGTON HARBOR PARKING ASSOCIATES, LLC AND BUFFINGTON HARBOR RIVERBOATS, L.L.C., (collectively, the "Debtors").

WHEREAS, the Debtors and the Secured Party entered into that certain Pledge and Security Agreement, dated as of October 7, 2003 (the "Pledge and Security Agreement") pursuant to which the Debtors granted the Secured Party a security interest in certain property;

WHEREAS, in accordance with the Pledge and Security Agreement, the Debtors and Secured Party entered into that certain Trademark Security Agreement, dated as of October 7, 2003 and that certain First Amendment to Trademark Security Agreement, dated as of December 21, 2005 (the "Trademark Security Agreements") for purposes of recording the Secured Party's security interest and lien in the Trademarks (as defined in Pledge and Security Agreement); and

WHEREAS, the Trademark Security Agreements were recorded with the United States Patent and Trademark Office on October 13, 2003 at Reel 2730 Frame 0829 and March 17, 2006 at Reel 3271 Frame 0188; and

WHEREAS, Debtors have paid in full the Secured Obligations (as defined in the Pledge and Security Agreement);

**NOW, THEREFORE**, for valuable consideration, the Secured Party hereby terminates and releases any and all security interests and liens, and re-assigns any rights, title and interest it may have, in the Trademarks, and all related goodwill, including all of those Trademarks referred to on Schedule A attached hereto.


