TRADEMARK SECURITY AGREEMENT

Trademark Security Agreement (this "Agreement") dated as of December 13, 2011 by and between YOUNG BROADCASTING OF SIOUX FALLS, INC., a Delaware corporation (the "Grantor"), having its chief executive office at 441 Lexington Avenue, 17th Floor New York, New York 10017 and WELLS FARGO BANK, NATIONAL ASSOCIATION, as Administrative Agent (the "Administrative Agent"), with offices at 1525 West W.T. Harris Blvd, MAC D1109-019, Charlotte, North Carolina 28262, for the ratable benefit of the banks and other financial institutions (the "Lenders") from time to time parties to that certain Credit Agreement, dated as of December 13, 2011 (the "Credit Agreement"), by and between New Young Broadcasting Holding Co., Inc., a Delaware corporation ("Holdings"), Young Broadcasting, LLC, a Delaware limited liability company (the "Borrower"), the Lenders party thereto and the Administrative Agent.

This Agreement is executed pursuant to the terms of that certain Collateral Agreement, dated as of December 13, 2011, by and among Holdings, the Borrower, certain Subsidiaries of Holdings (including the Grantor) party thereto and the Administrative Agent (the "Collateral Agreement"). Capitalized terms used herein but not defined herein shall have the meaning assigned to them in the Collateral Agreement.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Grantor hereby grants to the Administrative Agent, a continuing security interest in all of the Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter arising or acquired:

- (i) each Trademark, Trademark registration and Trademark application, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark, Trademark registration and Trademark application of the Grantor, including, without limitation, each Trademark, Trademark registration and Trademark application described on Schedule A;
- (ii) each Trademark License, including, without limitation, each Trademark License described on <u>Schedule B</u>;
- (iii) all claims by the Grantor against third parties for (a) past, present or future infringement or dilution of any Trademark or Trademark registration, including, without limitation, any Trademark or Trademark registration described on <u>Schedule A</u> or under any Trademark License described on <u>Schedule B</u>, (b) injury to the goodwill associated with any Trademark, Trademark registration or Trademark License or (c) breach or enforcement of any Trademark License; and
 - (iv) all products and proceeds of the foregoing.
