## INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT (this “Agreement”) is entered into as of December 19, 2011, between GIBSON GUITAR CORP., a Delaware corporation (the “Grantor”) and BANK OF AMERICA, N.A., as administrative agent (the “Administrative Agent”).

This Agreement is executed pursuant to the terms of (i) the Credit Agreement, dated as of March 25, 2011 and amended and restated pursuant to that First Amendment to the Credit Agreement dated as of November 14, 2011, (as further amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”) among the Grantor, as the borrower, the other Loan Parties party thereto, Bank of America, N.A., as administrative agent and the Lenders party thereto and (ii) the Pledge and Security Agreement, dated as of March 25, 2011 and reaffirmed pursuant to that certain Reaffirmation Agreement dated as of November 14, 2011, (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Pledge and Security Agreement”) executed by the Grantor and the other parties thereto in favor of the Administrative Agent, for the ratable benefit of itself and the Secured Parties. Capitalized terms used herein but not defined herein shall have the meaning assigned to them in the Credit Agreement or the Pledge and Security Agreement, as applicable.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Grantor hereby confirms the grant pursuant to the Pledge and Security Agreement, to the Administrative Agent, for the ratable benefit of itself and the Secured Parties, of a continuing security interest in all of the Grantor’s right, title and interest in, to and under the following, whether presently existing or hereafter arising or acquired:


- (a) all of its Trademarks and Trademark Licenses listed on Schedule A hereto;
- (b) all of its Patents and Patent Licenses, including, without limitation, those listed on Schedule B hereto;
- (c) all reissues, continuations or extensions of the foregoing; and
- (d) all rights, priorities and privileges relating to the foregoing, including all goodwill associated with any of the foregoing, and all rights to sue at law or in equity for any past, present or future infringement or other violation or impairment thereof, including the right to receive all proceeds and damages therefrom.

The rights and remedies of the Administrative Agent with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Pledge and Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Agreement are deemed to conflict with the Pledge and Security Agreement, the provisions of the Pledge and Security Agreement shall govern.
