### TRADEMARK RELEASE

THIS TRADEMARK RELEASE (this "Release"), is entered into as of December 23 2011 by UNION BANK, N.A. (formerly known as Union Bank of California, N.A.), as agent for the lenders ("Agent"), with places of business at (i) 445 South Figueroa Street, Los Angeles, California 90071 and (ii) 3403 Tenth Street, Suite 605, Riverside, California 92501, in connection with the grant of security interests in certain trademarks by K & N ENGINEERING, INC., a California corporation with an address at 1455 Citrus Street, Riverside, California 92507 (the "Grantor"), in favor of Agent.

### WITNESSETH:

WHEREAS, the Grantor entered into certain trademark agreements with Agent (i) dated August 9, 2000 (as amended, restated, supplemented or otherwise modified from time to time, the "First Trademark Agreement") which was recorded in the Trademark Division of the United States Patent and Trademark Office on September 1, 2000 at Reel 2146, Frame 0699, (ii) dated September 29, 2000 (as amended, restated, supplemented or otherwise modified from time to time, the "Second Trademark Agreement") which was recorded in the Trademark Division of the United States Patent and Trademark Office on October 18, 2000 at Reel 2179, Frame 0473, (iii) dated August 9, 2000 (as amended, restated, supplemented or otherwise modified from time to time, the "Third Trademark Agreement") which was recorded in the Trademark Division of the United States Patent and Trademark Office on December 8, 2004 at Reel 3092, Frame 0908, and (iv) dated August 9, 2000 (as amended, restated, supplemented or otherwise modified from time to time, the "Fourth Trademark Agreement") which was recorded in the Trademark Division of the United States Patent and Trademark Office on December 30, 2008 at Reel 3911, Frame 0296; in each case, for the purpose of providing certain trademarks as collateral security for the payment and performance of certain obligations of the Grantor to Agent, including, without limitation, the trademarks set forth on Schedule A attached hereto; and

WHEREAS, Grantor has requested that Agent release the entirety of its security interests in and lien on the Trademark Collateral (as defined below);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby agrees as follows:

- 1. <u>Definitions</u>. The term "<u>Trademark Collateral</u>", as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in all of the Grantor's trademarks (including, without limitation, those trademarks and trademark registrations listed on Schedule A attached hereto).
- 2. <u>Release of Security Interest</u>. Agent hereby terminates, cancels, releases and discharges all of its security interests in the Trademark Collateral. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest, if any, in and to the Trademark Collateral.
- 3. <u>Further Assurances</u>. Agent agrees to take such further action as may be reasonably requested by Grantor, from time to time, at Grantor's expense, to effectuate and carry out the provision and intent of this Release.

4. <u>Governing Law</u>. THIS TERMINATION AND RELEASE, AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK, WITHOUT REFERENCE TO CONFLICTS OF LAW PROVISIONS.
