**TERMINATION AND RELEASE  
OF  
TRADEMARK SECURITY AGREEMENT**

This Termination and Release of Trademark Security Agreement, (this "Release Agreement"), dated as of December 30, 2011, is made by BANK OF AMERICA, N.A. (the "Secured Party"), having a business location at 100 Federal Street, Boston, Massachusetts 02110.

WHEREAS, reference is made to that certain Intellectual Property Security Agreement dated as of October 4, 2005 (as amended, modified, restated or supplemented from time to time, the "IP Security Agreement"), by and among BROOKSTONE, INC., a Delaware corporation, BROOKSTONE COMPANY, INC., a New Hampshire corporation, BROOKSTONE INTERNATIONAL HOLDINGS, INC., a New Hampshire corporation, BROOKSTONE HOLDINGS, INC., a New Hampshire corporation, BROOKSTONE PROPERTIES, INC., a New Hampshire corporation, BROOKSTONE PURCHASING, INC., a New Hampshire corporation, BROOKSTONE PUERTO RICO, INC., a Puerto Rico corporation, BROOKSTONE STORES, INC., a New Hampshire corporation, ADVANCED AUDIO CONCEPTS, LTD., a Hong Kong corporation, GARDENERS EDEN, INC., a New Hampshire corporation, BROOKSTONE MILITARY SALES, INC., a New Hampshire corporation, BIG BLUE AUDIO LLC, a New Hampshire limited liability company, and BNM, LLC, a New Hampshire limited liability company, each with a business location at One Innovation Way, Merrimack, New Hampshire 03054 (collectively, the "Debtor") and the Secured Party;

WHEREAS, the IP Security Agreement was recorded with the U.S. Patent and Trademark Office on October 18, 2005, at Trademark Reel 3208 and Frame 0224;

WHEREAS, the Debtor and the Secured Party entered into a Supplement to Intellectual Property Security Agreement dated as of April 16, 2010 which was recorded with the U.S. Patent and Trademark Office on May 5, 2010, at Trademark Reel 4199 and Frame 0666 and which supplemented the IP Security Agreement;

WHEREAS, the Debtor and the Secured Party entered into a Joinder and Supplement to Intellectual Property Security Agreement dated as of November 18, 2011 which was recorded with the U.S. Patent and Trademark Office on November 18, 2011, at Trademark Reel 4663 and Frame 0610 and which supplemented the IP Security Agreement;

WHEREAS, the Debtor granted the Secured Party a security interest in and lien on, and collaterally assigned to the Secured Party all of its all of its intellectual property as defined in the IP Security Agreement, and more particularly identified on Exhibit A attached hereto (the "Trademarks");

WHEREAS, the Secured Party has agreed to terminate and release its security interest and all of its right, title and interest in each of the Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby agrees as follows:



1. Release and Assignment. The Secured Party hereby terminates and releases its security interest in and first priority lien on all of the Debtor's Trademarks, and the Secured Party hereby assigns and transfers to the Debtor, without recourse, all of the Secured Party's right, title and interest in and to each of the Trademarks and the related trademark registrations and goodwill, effective as of the date set forth above.

2. Miscellaneous.

(a) This Release Agreement shall be binding upon and inure to the benefit of the Debtor and the Secured Party and their respective participants, successors and assigns and shall take effect when signed by the Security Party and delivered to the Debtor.

(b) This Release Agreement shall be governed by the internal law of the State of New York without regard to conflicts of law provisions.
