
NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Assignor hereby sells, transfers, assigns and delivers to Assignee, effective as of the Effective Date, all right, title and interest in and to the Marks (including any registrations, registration applications and renewals thereof), together with all goodwill of the business associated with and symbolized by the Marks, including the right to seek or obtain any recovery, whether monetary, injunctive or otherwise, from any person or entity for past, present or future infringement or other violation of any of the rights under the Marks, the same to be held and employed by Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignors had this assignment not been made.

FURTHER, Assignor agrees to execute and provide promptly after its execution hereof, such further instruments, documents or assignments as may be reasonably necessary to effectuate the purposes of this transaction and to consolidate, vest and record in Assignee Assignor's rights in and to the Marks.


