THIS DEED OF ASSIGNMENT is made this 29th day of November 2011

BETWEEN **OOCL (LOGISTICS) HOLDINGS LIMITED**, a company incorporated in British Virgin Islands, having its registered office at Trident Chambers, P.O. Box 146, Road Town, Tortola, British Virgin Islands (hereinafter called "the Assignor") of the one part and **OOCL LOGISTICS LIMITED**, a company incorporated in the British Virgin Islands, having its registered office at Trident Chambers, P.O. Box 146, Road Town, Tortola, British Virgin Islands (hereinafter called "the Assignee") of the other part.

WHEREAS

- (A) The Assignor is the owner of all right, title and interest in and to the registered trade marks "**PODIUM**" and "**Podium Logo**" (hereinafter called "the Trade Marks") and has registered the Trade Marks in a number of countries. Particulars of such registrations are listed in the Schedule hereto.
- (B) It has been agreed between the Assignor and the Assignee that the Assignor shall assign to the Assignee as of 1 January 2011 its entire right, interest, title and goodwill in and to the Trade Marks in all of the countries in which the Trade Marks have been registered by the Assignor as hereinafter appears.

NOW THIS ASSIGNMENT WITNESSETH as follows:-

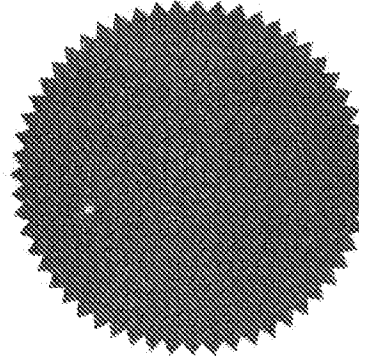

In pursuance of the said agreement and in consideration of the sum of Hong Kong Dollars One Hundred (HK\$100) now paid to the Assignor by the Assignee and of all other good and valuable consideration (the receipt and sufficiency of which the Assignor hereby acknowledges), the Assignor **HEERBY ASSIGNS AND TRANSFERS** unto the Assignee as of 1 January 2011 all property, right, title and interest in and to the Trade Marks **TOGETHER WITH** the entire goodwill associated with and symbolized by the Trade Marks **TO HOLD** the same unto the Assignee absolutely.
2. The Assignor hereby agrees to execute, acknowledge and deliver any and all further documents, papers, forms and authorizations and depose to or swear all declarations or oaths as may be necessary to make a record with any and all government agencies, authorities, courts, tribunals or third parties of the fact that the Assignee owns all right, title and interest in and to the Trade Marks and any and all goodwill associated therewith and that the Assignor no longer has any right, title or interest of any kind or nature in or to the Trade Marks.


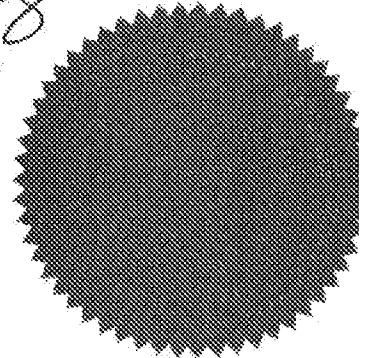

