- (1) Winc Design Limited, a company incorporated in Hong Kong and the registered address of which is at Unit O, 7th Floor, Kaiser Estate Phase III, No.11 Hok Yuen Street, Hung Hom, Hong Kong ("Assignor"), and
- (2) Pure Precision Limited, a company incorporated in the British Virgin Islands and the registered office of which is at P.O. Box 957, Offshore Incorporations Centre, Road Town, Tortola, British Virgin Islands ("Assignee").

WHEREAS:

- (A) As the date hereof, the Assignor is:
 - (i) the proprietor of the Trade Marks as listed in the Schedule I annexed hereto, including pending applications thereof, ("Trade Marks" and which term as used hereinbelow shall include any other applications for the registration of the mark of "Charlie Banana", and the double happiness logo alone or together with the Charlie Banana word mark that have been filed by the Assignor prior to the date hereof but not included in Schedule I),
 - (ii) the proprietor of the patents for inventions, utility models and/or designs as listed in the Schedule II annexed hereto, including pending applications thereof, ("Patents" and together with the Trade Marks, the "Intellectual Property Rights"), and
 - (iii) is indebted to the Assignee in the sum of HK\$688,000 ("Debt").
- (B) The Assignor has agreed to assign to the Assignee, and the Assignee has agreed to purchase from the Assignor, the Intellectual Property Rights, together with the goodwill of the business concerned in the goods/services for which the Intellectual Property Rights are or may become registered or applied to ("Goodwill"), for the sum of HK\$888,000 ("Purchase Price").

IT IS HEREBY AGREED as follows:-

1. In pursuance of the said agreement and in consideration of the Purchase Price, the Assignor as beneficial owner does hereby assign and transfer to the Assignee with effect from the Effective Date all the Assignor's rights, title, interests and property in the

Intellectual Property Rights together with the full and exclusive benefit thereof, all common law rights and any copyright rights which may subsist in the Trade Marks and any drawings, sketches and other documents with respect to the Patents and all rights, privileges and advantages appertaining thereto and further TOGETHER WITH:-

- (a) the Goodwill, and
- (b) the right by the Assignee to recover and to bring proceedings to recover damages and/or to obtain other remedies in respect of infringement of any rights in or relating to any of the Intellectual Property Rights whether committed before or after the date of this Assignment, to the intent that the Intellectual Property Rights shall be in the name of and shall vest in the Assignee,

And TO HOLD the same unto the Assignee absolutely.

- 2. The Assignor and the Assignee agree that the Debt shall be applied in part payment, settlement or set off against the Purchase Price or vice versa on the date hereof without the need to exchange physical payment or remittance, and thus the Assignor acknowledges receipt or satisfaction of the Purchase Price to the extent of the Debt through the execution of this Assignment. The balance of the Purchase Price in the sum of HK\$200,000 shall be held as security for the performance of the Assignor's obligations under the License Agreement (including the obligation to effect payment of royalty) to be entered into within seven days from the date hereof between the Assignor and the Assignee if the Assignor shall request a license of the Intellectual Property Rights from the Assignee within such time.
- 3. The Assignor covenants and undertakes that the Assignor has not done or omitted to do and will not do or omit to do any act, matter or thing whereby the Intellectual Property Rights or any of them may be invalidated.
- 4. The Assignor warrants that it is the legal and beneficial owner of all the Intellectual Property Rights, the Intellectual Property Rights are not subject to any charge, pledge, mortgage or any other form of encumbrance in favour of any third party and do not infringe the intellectual property rights of any person, company, partnership, organization or entity.
- 5. The Assignor agrees that the Assignee shall have the right to record or register the assignment of any of the Intellectual Property Rights unto or in favour of the Assignee or any of its nominees in such registry for the registration of any form of intellectual property rights in any country or place in the world as and when the Assignee considers appropriate, and the Assignor shall execute and deliver all such documents as may be

- reasonably required by the Assignee for such purpose, it being understood any such recordals or registrations shall be at the costs of the Assignee.
- 6. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto, and their respective successors and assigns.
- 7. In the event that any provisions of this Assignment shall be determined by a court of competent jurisdiction to be unenforceable or ineffective, the same shall be deemed severed from this Assignment without effect on the remaining provisions hereof which shall continue to remain fully enforceable and effective.
- 8. This Assignment shall be construed and interpreted in accordance with the laws of the Hong Kong Special Administrative Region of the People's Republic of China ("Hong Kong"), and the courts of Hong Kong shall have jurisdiction to hear and determine any dispute or claim arising out of this Assignment. Each party hereto agrees to submit to the jurisdiction of the courts of Hong Kong for such purpose.
