**CONFIRMATORY ASSIGNMENT OF SECURITY INTEREST  
IN PATENTS, TRADEMARKS, AND COPYRIGHTS**

THIS CONFIRMATORY ASSIGNMENT OF SECURITY INTEREST IN PATENTS, TRADEMARKS, AND COPYRIGHTS (the "*Confirmatory Assignment*") is dated as of December 1, 2011, by and from VINCIT COMPANY, LLC, a Tennessee limited liability company (the "*Assignor*"), whose principal address is 412 Georgia Avenue, Suite 300, Chattanooga, Tennessee 37403, to and in favor of BMO HARRIS BANK, N.A., whose principal address is 111 West Monroe Street, Chicago, Illinois 60603 (the "*Assignee*") in connection with that certain Credit Agreement dated as of the date hereof by and among the Assignor, STELLAR MANAGEMENT COMPANY GROUP, INC., a Tennessee corporation, STELLAR MANAGEMENT GROUP I, INC., a Nevada corporation, STELLAR MANAGEMENT GROUP II, INC., a Nevada corporation, STELLAR MANAGEMENT GROUP III, INC., a Nevada corporation, STELLAR MANAGEMENT GROUP IV, INC., a Nevada corporation, STELLAR MANAGEMENT GROUP V, INC., a Nevada corporation, TOWER CLEANING SPECIALISTS, LLC, a Tennessee limited liability company, PRO-LOGISTICS, LLC, a Nevada limited liability company, ZECO, INC. a Tennessee corporation, ZEE COMPANY, INC. a Tennessee corporation, ITG, LLC, a Tennessee limited liability company, and EIS OF TENNESSEE ACQUISITION COMPANY, LLC, a Tennessee limited liability company, F-90, LLC, a North Carolina limited liability company (each a "*Borrower*" and, collectively, the "*Borrowers*"), Assignee, as the bank, as amended, restated, supplemented, otherwise modified or refinanced from time to time (the "*Credit Agreement*").

WHEREAS, each of the Borrowers (including the Assignor), as debtors, and Assignee, as secured party, have entered into a General Security Agreement dated as of even date herewith (as amended, restated, supplemented or otherwise modified from time to time, the "*Security Agreement*") pursuant to which the Assignor has granted Assignee a security interest in substantially all of Assignor's personal property and assets;

WHEREAS, the Assignor is the owner of the patents (the "*Patents*"), the trademarks, trademark applications and the goodwill of the business in connection therewith (the "*Trademarks*"), and the copyrights (the "*Copyrights*"), all listed on Exhibit A attached hereto, which Patents are issued or pending with the United States Patent and Trademark Office; which Trademarks are registered or pending registration with the United States Patent and Trademark Office; and which Copyrights are registered or pending with the United States Copyright Office.

WHEREAS, this Confirmatory Assignment has been granted in conjunction with the security interest granted to Assignee under the Security Agreement;

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1) **Definitions.** All capitalized terms not defined herein shall have the respective meaning given to them in the Security Agreement.

2) ***The Security Interest.***

(a) This Confirmatory Assignment is made to secure the satisfactory performance and payment of all the Secured Obligations (as defined in the Security Agreement). Upon the indefeasible payment in full in cash of all Secured Obligations, Assignee shall, upon such satisfaction, execute, acknowledge, and deliver to the Assignor an instrument in writing releasing the security interest in the Patents, Trademarks, and Copyrights acquired under this Confirmatory Assignment.

(b) The Assignor hereby assigns and grants to Assignee a security interest in (1) all of the Assignor's right, title and interest in and to the Patents, Trademarks, and Copyrights set forth on Exhibit A, now owned or from time to time after the date hereof owned or acquired by the Assignor, together with (2) all proceeds and products of the Patents, Trademarks, and Copyrights, and (3) all causes of action arising prior to or after the date hereof for infringement of any of the Patents, Trademarks, or Copyrights, or unfair competition regarding the same.

(c) Assignor shall promptly notify the Assignee in writing of any additional intellectual property rights acquired or arising after the date hereof, and shall submit to Assignee a supplement to Exhibit A to reflect such additional rights (provided that any failure to do so shall not impair the Assignee's security interest therein).

(d) The rights and remedies of Assignee with respect to the security interest granted herein are without prejudice to and are in addition to those set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Confirmatory Assignment are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.
