## ASSIGNMENT AND ASSUMPTION AGREEMENT

Reference is made to (i) the Trademark Security Agreement, dated as of August 3, 2010 (the "Trademark Security Agreement"), between Kroll Inc., Kroll Associates, Inc., Kroll Factual Data, Inc., Kroll Ontrack Inc., TrialGraphix, Inc. (collectively, the "Trademark Grantors") and Lehman Commercial Paper Inc., as Collateral Agent for the Secured Parties (the "Resigning Agent"), (ii) the Patent Security Agreement, dated as of August 3, 2010 (the "Patent Security Agreement"), between Kroll Ontrack Inc. and the Resigning Agent and (iii) the Copyright Security Agreement, dated as of August 3, 2010 (the "Copyright Security Agreement") between Kroll Inc., Kroll Ontrack Inc. (together, the "Copyright Grantors") and the Resigning Agent (together with the Trademark Security Agreement and Patent Security Agreement, the "Intellectual Property Security Agreements").

Capitalized terms not otherwise defined herein have the respective meanings ascribed to them in the Intellectual Property Security Agreements, as applicable.

WHEREAS, pursuant to the Trademark Security Agreement, and the security interest that was recorded with the U.S. Patent and Trademark Office on September 9, 2011 at Reel/Frame Nos. 004620/0467, 004620/0459, 004620/0475, 004620/0483 and 004620/0491, each Trademark Grantor granted the Resigning Agent a lien on and security interest in all right, title or interest in or to any and all Trademark Collateral of such Trademark Grantor listed on Schedule I hereto;

WHEREAS, pursuant to the Patent Security Agreement, and the security interest that was recorded with the U.S. Patent and Trademark Office on September 9, 2011 at Reel/Frame No. 026883/0916, Kroll Ontrack Inc. granted the Resigning Agent a lien on and security interest in all of its right, title or interest in or to any and all Patent Collateral listed on Schedule II hereto; and

WHEREAS, pursuant to the Copyright Security Agreement, and the security interest that was sent by U.S. Express Mail to the Library of Congress, Copyright Office on September 30, 2011, each Copyright Grantor granted the Resigning Agent a lien on and security interest in all right, title or interest in or to any and all Copyright Collateral of such Copyright Grantor listed on Schedule III hereto;

WHEREAS, pursuant to the Resignation, Waiver, Consent and Appointment Agreement dated as of August 3, 2010, between the Resigning Agent, the Successor Agent (as defined below) and the other parties thereto (the "Appointment Agreement"), (a) the Resigning Agent resigned as Collateral Agent and assigned to the Successor Agent (as defined below) all liens and security interests granted or assigned to the Resigning Agent under the Loan Documents (as defined in the Credit Agreement) and (b) the Successor Agent assumed all such liens and security interests for its benefit and the benefit of the Secured Parties;

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Resigning Agent and Goldman Sachs Bank USA (the "Successor Agent") hereby agree as follows:

This Assignment and Assumption Agreement is made as of January 19, 2012 (the "Execution Date") but effective as of the Transfer Date (as defined below).

All liens and security interests granted to the Resigning Agent pursuant to the Intellectual Property Security Agreements were assigned to the Successor Agent pursuant to the Appointment Agreement on August 3, 2010 (the "Transfer Date").

From and after the Transfer Date, (a) the Successor Agent became a party to the Intellectual Property Security Agreements and assumed the rights and obligations of the Collateral Agent thereunder and under the other Loan Documents (as defined in the Credit Agreement) and became bounded by the provisions thereof, and (b) the Resigning Agent relinquished its rights and was released from its obligations under the Intellectual Property Security Agreements.


