SECOND LIEN TRADEMARK SECURITY AGREEMENT

This **SECOND LIEN TRADEMARK SECURITY AGREEMENT**, dated as of December 9, 2011 (as it may be amended, restated, supplemented or otherwise modified from time to time, this "Agreement"), is made by the entities identified as grantors on the signature pages hereto (collectively, the "Grantors") in favor of Goldman Sachs Bank USA, as Administrative Agent for the Secured Parties (in such capacity, together with its successors and permitted assigns, the "Administrative Agent").

WHEREAS, the Grantors are party to (a) a U.S. Collateral Agreement dated as of December 9, 2011 (as amended, restated, supplemented, waived or otherwise modified from time to time, the "Second Lien Collateral Agreement"), among CKX Entertainment, Inc. (the "Borrower"), CKX, Inc. (the "Company"), each other Subsidiary of the Borrower identified therein and the Administrative Agent and (b) a Second Lien Term Loan Agreement, dated as of December 9, 2011 (as amended, restated, supplemented, waived or otherwise modified from time to time), among the Borrower, the Company, the Lenders party thereto from time to time and the Administrative Agent, pursuant to which the Grantors granted a security interest to the Administrative Agent in the Trademark Collateral (as defined below) and are required to execute and deliver this Agreement.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantors hereby agree with the Administrative Agent as follows:

SECTION 1. Defined Terms

Unless otherwise defined herein, terms defined in the Second Lien Collateral Agreement and used herein have the meaning given to them in the Second Lien Collateral Agreement.

SECTION 2. Grant of Security Interest

SECTION 2.1 Grant of Security. As security for the payment or performance, as the case may be, in full of the Obligations, each Grantor hereby assigns and pledges to the Administrative Agent, its successors and assigns, for the benefit of the Secured Parties, and hereby grants to the Administrative Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest in all right, title and interest in, to or under any and all of the following assets and properties now owned or at any time hereafter acquired by such Grantor or in, to or under which such Grantor now has or at any time in the future may acquire any right, title or interest (collectively, the "Trademark Collateral"):

- (a) all trademarks, service marks, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office or any similar offices in any State of the United States or any other country or any political subdivision thereof, and all

extensions or renewals thereof, including those set forth on Schedule A under the heading "Trademark Registrations and Applications"; and

(b) all goodwill associated therewith or symbolized thereby.

SECTION 2.2 Certain Limited Exclusions. Notwithstanding anything herein to the contrary, in no event shall the Trademark Collateral include or the security interest granted under Section 2.1 hereof attach to any applications for trademarks and service marks filed in the U.S. Patent and Trademark Office on the basis of a Grantor's intent to use any such mark pursuant to 15 U.S.C. § 1051 Section 1(b) unless and until evidence of use of the mark in interstate commerce is submitted to the U.S. Patent and Trademark Office pursuant to 15 U.S.C. § 1060(a), at which point the security interest granted herein shall attach to each such application.

SECTION 3. Security Agreement

The security interest granted pursuant to this Agreement is granted in conjunction with the security interest granted to the Administrative Agent, for the benefit of the Secured Parties, pursuant to the Second Lien Collateral Agreement, and the Grantors hereby acknowledge and affirm that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Second Lien Collateral Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Agreement is deemed to conflict with the Second Lien Collateral Agreement, the provisions of the Second Lien Collateral Agreement shall control.

SECTION 4. Governing Law

THIS AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.

SECTION 5. Counterparts

This Agreement may be executed in two or more counterparts, each of which shall constitute an original but all of which when taken together shall constitute but one contract. Delivery of an executed counterpart to this Agreement by facsimile or other electronic transmission shall be as effective as delivery of a manually signed original.

SECTION 6. Subject to Intercreditor Agreement

Notwithstanding anything herein to the contrary, (i) the liens and security interests granted to the Administrative Agent pursuant to this Agreement are expressly subject and subordinate to the liens and security interests granted in favor of the Senior Secured Parties under and as defined in the Second Lien Intercreditor Agreement dated as of December 9, 2011, among CKX Entertainment, Inc., CKX, Inc., the other Grantors party thereto, Goldman Sachs Bank USA, as Senior Collateral Agent and Senior Representative for the Credit Agreement Secured Parties, Goldman Sachs Bank USA, as Senior Collateral Agent and Senior Representative for the First Lien Term Loan Secured Parties, and Goldman Sachs

Bank USA, as Second Priority Collateral Agent and Second Priority Representative for the Second Lien Term Loan Secured Parties, and the additional Representatives and Collateral Agents from time to time party thereto (as amended, restated, supplemented or otherwise modified from time to time, the "Second Lien Intercreditor Agreement"), including liens and security interests (a) granted to Goldman Sachs Bank USA, as administrative agent, pursuant to or in connection with the Credit Agreement dated as of June 21, 2011, as amended and restated as of December 9, 2011 (as further amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among CKX Entertainment, Inc., CKX, Inc., the lenders party thereto from time to time, and Goldman Sachs Bank USA, as administrative agent (the "Credit Agreement Administrative Agent") and swingline lender, and (b) granted to Goldman Sachs Bank USA, as administrative agent, pursuant to or in connection with the First Lien Term Loan Agreement dated as of December 9, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "First Lien Term Loan Agreement"), among CKX Entertainment, Inc., CKX, Inc., the lenders party thereto from time to time, and Goldman Sachs Bank USA, as administrative agent (the "First Lien Term Loan Administrative Agent"), and (ii) the exercise of any right or remedy by the Administrative Agent hereunder is subject to the limitations and provisions of the Second Lien Intercreditor Agreement. In the event of any conflict between the terms of the Second Lien Intercreditor Agreement and the terms of this Agreement, the terms of the Second Lien Intercreditor Agreement shall govern.
