**RELEASE OF
TRADEMARK SECURITY AGREEMENT**

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release"), effective as of December 22, 2011, is made by **CAPITAL SOUTH PARTNERS FUND II LIMITED PARTNERSHIP**, a North Carolina limited partnership, and **CAPITALSOUTH PARTNERS SBIC FUND III, L.P.**, a Delaware limited partnership ("collectively, "CapitalSouth"), and **EAGLE FUND I, L.P.**, a Missouri limited partnership, and **EAGLE FUND II, L.P.**, a Missouri limited partnership (collectively, "Bush O'Donnell", and collectively, with CapitalSouth, "Lenders"), and **CAPITALSOUTH PARTNERS SBIC FUND III, L.P.**, in its capacity as collateral agent for CapitalSouth and Bush O'Donnell (in such capacity on behalf of the Lenders and collectively with the lenders, the "Secured Party"), and is as follows:

WHEREAS, FURMINATOR, INC., an Indiana corporation ("Debtor"), and Secured Party are parties to a Trademark Security Agreement dated as of September 10, 2008, which was recorded with The United States Patent and Trademark Office on September 12, 2008 in its records at Reel 03852, Frame 0284 and a second Trademark Security Agreement dated as of June 7, 2011 which was recorded with The United States Patent and Trademark Office on July 18, 2011 at Reel 04584, Frame 0649 (hereinafter known collectively as the "Agreements"). Capitalized terms used but not defined herein will have the meaning given to them in the Agreements;

WHEREAS, the Agreements granted to the Secured Party a security interest in all of the Debtor's right, title and interest in, to and under the Trademark Collateral (as defined in the Agreements), including, without limitation (a) all of Debtor's right, title and interest in and to all of its now or in the future owned or existing Trademarks listed on Schedule I of the Agreements (attached hereto and made a part hereof as Schedule I); (b) all renewals of each of the Trademarks; (c) all income, royalties, damages and payments now and in the future due or payable under or with respect to any and all Trademarks, including damages and payments for past or future infringements of any and all Trademarks; (d) all rights to sue for past, present and future infringements of any and all Trademarks; (e) all rights corresponding to each of the Trademarks throughout the world; (f) all of Debtor's Trademark License Rights (as defined in the Agreements); and (g) together in each case with the goodwill of Debtor's business connected with the use of, and symbolized by, the foregoing; and

WHEREAS, Secured Party desires to release its rights and security interests in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby fully and finally releases and terminates (i) its security interest and other rights in, to and under the Trademark Collateral and (ii) any and all other rights it may have under the Agreements.


