RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS (this "**Release**") dated as of January 3, 2012, by Credit Suisse AG as Collateral Agent (as defined below) for the Lenders, in favor of each Grantor listed on Schedule I hereto (the "**Grantors**"). Terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement referred to below.

A. Reference is made to the Second Lien Credit Agreement dated as of May 11, 2007 (as amended, restated, supplemented or otherwise modified from time to time prior to the date hereof) (the "**Credit Agreement**"), among Deluxe Entertainment Services Group Inc. (the "**Borrower**"), DX Holdings LLC ("**Holdings**"), the lenders from time to time party thereto (the "**Lenders**"), Credit Suisse AG (f/k/a Credit Suisse), as administrative agent and as collateral agent (in such capacity, the "**Collateral Agent**") and the other agents thereunder.

B. Reference is made to the Second Lien Guarantee and Collateral Agreement, dated as of May 11, 2007 (as amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the "**Guarantee and Collateral Agreement**"), among the Borrower, Holdings, the Grantors and certain affiliates thereof from time to time party thereto and the Collateral Agent, pursuant to which, among other things, the Borrower granted a security interest to the Collateral Agent, for the benefit of certain secured parties named therein, in, among other things, the registered trademarks and pending trademark applications of the Borrower and certain of its subsidiaries set forth on Annex I hereto (the "**Trademarks**"), pursuant to:

(i) the Second Lien Trademark Security Agreement dated as of May 11, 2007, among Deluxe Digital Media Management, Inc., EFILM, LLC, Deluxe Laboratories, Inc., Softtiter Net, Inc., Shug, Inc., Deluxe Digital Studios, Inc., MediaVu LLC and Credit Suisse AG (f/k/a Credit Suisse) as second lien collateral agent, recorded with the United States Patent and Trademark Office (the "PTO") on May 15, 2007 at Reel 003542/Frame 0364 and

(ii) the Second Lien Trademark Security Agreement dated as of February 23, 2011, among Composite Image Systems, LLC, Deluxe Digital Media Management, Inc., Deluxe Digital Studios, Inc., Deluxe Laboratories, Inc., Deluxe Media Group LLC (formerly known as Ascent Media Group, LLC), EFILM, LLC and Credit Suisse AG as second lien collateral agent, recorded with the PTO on April 22, 2011 at Reel 004527/Frame 0014.

D. In connection with the termination of the Guarantee and Collateral Agreement, the Borrower has informed the Collateral Agent of its desire to obtain the release of all right, title and interest of the Collateral Agent, the Lenders and each other grantee or beneficiary in and to the Trademarks granted under the Guarantee and Collateral Agreement.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, all the Collateral Agent's right, title and interest (including, without limitation, security interests) in and to the Trademarks pursuant to the Guarantee and Collateral Agreement shall automatically terminate as provided in the Guarantee and Collateral Agreement, including, without limitation, the Trademarks set forth on Annex I attached hereto, the debt secured thereby having been paid and satisfied in full and any right, title or interest of the Collateral Agent in such Trademarks shall hereby cease and become void.

The Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby at the cost and request of the Grantors. This Release shall be construed in accordance with and governed by the laws of the State of New York.


