ASSIGNMENT AND CO-EXISTENCE AGREEMENT

This ASSIGNMENT AND CO-EXISTENCE AGREEMENT ("Assignment and Co-Existence Agreement"), is entered into as of November \_\_, 2011, shall be effective as of the funding date (which shall be no later than November 30, 2011) (the "Effective Date"), and is entered into between PLR IP HOLDINGS, LLC ("PLR") and STYLEMARK EYEWEAR HOLDING, B V ("StyleMark"), the designee of STYLEMARK, INC. ("Holdco") pursuant to Section 2(c) of that certain Prepayment Closing Agreement as hereinafter defined. (Each of PLR and StyleMark are sometimes referred to hereinafter individually as a "Party" and collectively as the "Parties")

WITNESSETH:

WHEREAS, Polaroid Corporation n/k/a PBE Corporation ("Polaroid"), a Delaware corporation, previously owned all right, title and interest in the trademarks, trade names and internet domain names of the Polaroid eyewear business as set forth in Schedules A-D to this Assignment and Co-Existence Agreement, and the goodwill associated therewith (collectively, the "Polaroid Eyewear Trademarks and Domain Names"),

WHEREAS, PLR hereby desires to sell and assign to StyleMark, and StyleMark desires to purchase from PLR, the Polaroid Eyewear Trademarks and Domain Names for use within the StyleMark Field of Use (as defined hereafter); and

WHEREAS, the Parties wish to set forth the manner in which they will co-exist in the marketplace following said assignment, whereby StyleMark shall have exclusive ownership of the Polaroid Eyewear Trademarks and Domain Names for use within the StyleMark Field of Use and PLR shall retain exclusive ownership of all trademarks, trade names and domain names for use in the PLR Field of Use (as defined hereafter);

NOW THEREFORE, for and in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, PLR and StyleMark hereby agree as follows:

1 Definitions.

1 01 "Affiliate" shall mean any Person which, directly or indirectly, controls, is controlled by or is under common control with another Person; and, for the purposes of this definition, "control" (including, with correlative meanings, the terms "controlled by" or "under common control with") means the power to direct or cause the direction of the management and policies of any Person, whether through the ownership of shares or other economic interests, the holding of voting rights or contractual rights or otherwise

1 02 "Assigned Internet Domain Names" shall mean all Internet domain names listed on Schedule C, as may be amended by the Parties from time to time

1 03 "Assigned Marks" shall mean all Single Use Eyewear Marks and all Combined Use Eyewear Marks.

1.08 "Contact Lens Accessories" shall mean contact lens cases, including self-cleaning contact lens cases, contact lens cleaning solution, and such other products mutually agreed upon by the Parties in writing, marketed under or in connection with one or more of the Polaroid Eyewear Trademarks

1.10 "Eyewear Trademark Filing" shall mean all trademark registrations and applications filed in the name of PLR at the written request of StyleMark and covering goods specifically stated to be within the StyleMark Field of Use

1.11 "Field of Use" shall mean the StyleMark Field of Use and/or the PLR Field of Use, as applicable

1.12 "Goggles" shall mean all articles or devices (i) whose primary purpose is to provide protection to the eyes of the user from natural elements such as wind, water and cold; (ii) that cover and provide a seal around the eyes; and (iii) that have as a component part thereof a lens. Goggles shall specifically exclude (i) any helmet or headwear (regardless of whether such helmet or headwear has an integral eye covering); (ii) any scuba masks and other masks that cover the entire face such as welding masks; and (iii) any goggles whose primary purpose is not to provide protection to the eyes including, but not limited to, night vision goggles and goggles used as part of an electronic or video gaming system or virtual reality system. Goggles may include electronic components, where such electronic components are incidental to the purpose of Goggles as a device to protect the eyes from natural elements such as wind, water and cold

1.14 "Optical Accessories" shall mean lens cleaning cloths, eyeglass retail eyeglass cases and eyeglass repair kits

1.15 "Optical Frames" shall mean eyeglass frames, sunglass frames and spectacle frames, and component parts thereof. Optical Frames may include electronic components, where such electronic components are incidental to the purpose of Optical Frames as a device to encase lenses.

1.16 "Person" shall mean an individual, partnership, corporation (including a business trust), limited liability company, joint stock company, trust, unincorporated association, joint venture or other entity, or a government or any political subdivision or agency thereof.

1.17 "PTM Field of Use" shall mean all goods or services other than those goods within the StyleMark Field of Use.

1.18 "Prescription Eyeglasses" shall mean finished eyeglasses, reading glasses and prescription glasses, and component parts thereof. Prescription Eyeglasses may include electronic components, where such electronic components are incidental to the purpose of Prescription Eyeglasses as a device to provide improved sight.

1.19 "Prescription and Non-prescription Lenses" shall mean ophthalmic lenses, prescription contact lenses and non-prescription contact lenses. Prescription and Non-prescription Lenses may include electronic components, where such electronic components are incidental to the purpose of Prescription and Non-prescription Lenses as a device to provide improved sight.

1.20 "Safety Glasses" shall mean non-prescription finished eyeglasses that are designed to protect the eye in an industrial, clinical or laboratory setting. Safety Glasses may include electronic components, where such electronic components are incidental to the purpose of Safety Glasses as a device to protect the eyes.

1.22 "Stereographic Eyeglasses" shall mean eyeglasses (i) whose lenses are designed to create a stereographic image for the wearer such as 3D eyeglasses; and (ii) which are intended to be sold alone and not part of an electronic gaming or other system. Stereographic Eyeglasses may include electronic components, where such electronic components are incidental to the purpose of Stereographic Eyeglasses as a device to create a stereographic image.

1.23 "StyleMark Field of Use" shall mean eyewear, namely, Sunglasses, Prescription Eyeglasses, Prescription and Non-prescription Lenses, Optical Frames, Goggles, Stereographic Eyeglasses, Safety Glasses, Optical Accessories and Contact Lens Accessories; provided that the StyleMark Field of Use does not include (i) headwear of any kind, including helmets or hats; (ii) eyewear sold as part of an electronic or video gaming system or virtual reality system; (iii) eyewear including a camera or videocamera; or (iv) services of any kind, including, but not limited to, retail store services featuring the sale of eyewear products or ophthalmological or optician services, provided that; for the avoidance of doubt, StyleMark shall be permitted to

engage in promotional activities, product displays, and post-purchase product repair and replacement services

1.24 "StyleMark Entities" shall mean, individually and collectively, StyleMark and any Affiliate of StyleMark that now or in the future becomes an assignee or user (during the time it is a user) of any Polaroid Eyewear Trademarks and Domain Names for goods specifically stated to be within the StyleMark Field of Use, which as of the Effective Date shall include StyleMark GmbH (f/k/a StyleMark A.G.), StyleMark B.V., StyleMark S.p.A., StyleMark AB and StyleMark UK Limited, but shall not include Holdco (which represents that it shall not be a user of the Polaroid Eyewear Trademarks and Domain Names as of the Effective Date).

1.25 "Sunglasses" shall mean non-prescription finished sunglasses, non-prescription sunglass lenses and non-prescription clip-on sunglasses, fit-over sunglasses and component parts thereof. Sunglasses may include electronic components such as (i) sensors that control the degree of lens transmittance and (ii) UV meters, where such electronic components are incidental to the purpose of Sunglasses as a device to protect the eyes from the sun.

## 2 Assignment

2.01 Subject to the terms and conditions set out herein, PLR hereby grants, assigns, transfers, sells and conveys to StyleMark, its successors and assigns as of the Effective Date all of PLR's right, title and interest in and to the Polaroid Eyewear Trademarks and Domain Names as limited to goods within the StyleMark Field of Use, including the goodwill therein, the right to register the Polaroid Eyewear Trademarks and Domain Names, together with any and all common law rights associated therewith, and the right of PLR to take action, claim relief and recover damages in respect of infringements occurring within the StyleMark Field of Use, whether prior or subsequent to the Effective Date of this Assignment and Co-Existence Agreement, in any country throughout the world.

2.02 The Parties acknowledge and agree that the transfer of the Polaroid Eyewear Trademarks and Domain Names is made subject to the laws and/or rules imposed by the applicable authorities and/or governing boards having jurisdiction over the registration of trademarks and internet domain names as may be applicable from time to time.

2.03 PLR expressly agrees and acknowledges that StyleMark shall have the right in the exercise of its sole discretion to grant licenses and sublicenses to third parties to use Combined Use Eyewear Marks within the StyleMark Field of Use under terms and conditions that shall be consistent with this Assignment and Co-Existence Agreement.

2.04 The Parties acknowledge and agree that nothing in this Assignment and Co-Existence Agreement prohibits or otherwise restricts PLR, its successors and assigns from manufacturing, distributing or selling, or licensing others to manufacture, distribute or sell, any electronic components whatsoever, notwithstanding the fact that such electronic components may be an incidental component of goods within the StyleMark Field of Use.

13. Successors. Subject to StyleMark's obligations under Section 14 below, this Assignment and Co-Existence Agreement is freely transferable or assignable by either Party, in whole or in part, subject to: (i) prior written disclosure to the non-transferring Party; and (ii) providing the non-transferring Party with a written agreement signed by the transferee that obligates such transferee to be bound by this Assignment and Co-Existence Agreement and all Schedules thereto to the same extent as PLR or StyleMark

15. Confidentiality. The Parties, where reasonably necessary, may disclose the fact of the assignment and the Parties' agreement to co-exist within their respective Fields of Use as provided for herein. Notwithstanding the foregoing, the specific terms and conditions of this Assignment and Co-Existence Agreement shall be kept confidential by PLR and each of StyleMark Entities, except as required by law or court order ("Permitted Disclosure"). In the event of any Permitted Disclosure, the disclosing Party shall notify the other in writing and, where reasonably possible, prior to such disclosure taking place.

16. Recordation. PLR and StyleMark agree that a short form assignment suitable for recordation and reflecting the fact of the assignment from PLR to StyleMark hereunder may be recorded, where
