TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT ("Agreement"), dated and effective as of February 2, 2012, is made by each entity listed on Annex A hereto (each a "Grantor"), in favor of The Bank of New York Mellon Trust Company, N.A., a national banking association, having its designated corporate trust office located at 525 William Penn Place, 38th Floor Pittsburgh, Pennsylvania 15259, as Collateral Agent (the "Collateral Agent") for the Secured Parties.

W I T N E S S E T H:

WHEREAS, pursuant to the Indenture dated as of February 2, 2012 (as amended, restated, supplemented, waived or otherwise modified from time to time, the "Indenture"), among Realogy Corporation (the "Company"), Domus Intermediate Holdings Corp., Domus Holdings Corp., the Subsidiaries of the Company party thereto as guarantors, and The Bank of New York Mellon Trust Company, N.A., as trustee, the Company has duly authorized the issuance of 7.625% Senior Secured First Lien Notes Due 2020 (the "Notes");

WHEREAS, pursuant to the Indenture, the Holders have agreed to extend credit to the Company subject to the terms and conditions set forth in the Indenture;

WHEREAS, in connection with the Indenture, each Grantor has executed and delivered a First Lien Priority Collateral Agreement, dated and effective as of February 2, 2012, in favor of the Collateral Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "Collateral Agreement");

WHEREAS, pursuant to the Collateral Agreement, each Grantor pledged and granted to the Collateral Agent for the benefit of the Collateral Agent and the Secured Parties a continuing security interest in all Intellectual Property, including the Trademarks; and

WHEREAS, each Grantor has duly authorized the execution, delivery and performance of this Agreement;

NOW THEREFORE, in consideration of the mutual covenants and agreements of the parties and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and in order to induce the Holders to extend the credit to the Company pursuant to the Indenture and the Notes, each Grantor agrees, for the benefit of the Collateral Agent and the Secured Parties, as follows:

SECTION 1. Definitions. Capitalized terms used in this Agreement and not otherwise defined herein have the respective meanings assigned thereto in the Collateral Agreement or the Indenture, as applicable.

SECTION 2. Grant of Security Interest. As security for the payment or performance when due (whether at the stated maturity, by acceleration or otherwise), as the case may be, in full of its Secured Obligations, each Grantor hereby grants to the Collateral Agent, its successors and permitted assigns, for the benefit of the Secured Parties, a security interest in all right, title and interest in or to any and all of the Trademarks now owned or at any time hereafter acquired by such Grantor or in which such Grantor now has or at any time in the future may acquire any right, title or interest (including, without limitation, those items listed on Annex B hereto) (collectively, the "Collateral").

SECTION 3. Purpose. This Agreement has been executed and delivered by each Grantor for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office. The security interest granted hereby has been granted in connection with the Collateral Agreement and is expressly subject to the terms and conditions thereof. The Collateral Agreement (and all rights and remedies of the Secured Parties thereunder) shall remain in full force and effect in accordance with its terms.

SECTION 4. Acknowledgment.

(a) Each Grantor does hereby further acknowledge and affirm that the rights and remedies of the Secured Parties with respect to the security interest in the Collateral granted hereby are more fully set forth in the Collateral Agreement and the Intercreditor Agreements, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if set forth herein.

(b) Notwithstanding any provision to the contrary, the liens and security interests granted to the Collateral Agent pursuant to this Agreement, and the exercise of any right or remedy by the Collateral Agent hereunder are subject to the provisions of the Intercreditor Agreements.

(c) In the event of any conflict between the terms of this Agreement and the terms of the Collateral Agreement and the Intercreditor Agreements, the terms of the Collateral Agreement and the Intercreditor Agreements shall govern and control.

SECTION 5. Counterparts. This Agreement may be executed in two or more counterparts, each of which shall constitute an original but all of which when taken together shall constitute but one contract. Delivery of an executed counterpart to this Agreement by facsimile or electronic transmission shall be as effective as delivery of a manually signed original.

SECTION 6. GOVERNING LAW. THIS AGREEMENT AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.

SECTION 7. WAIVER OF JURY TRIAL. EACH PARTY HERETO HEREBY WAIVES, TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, ANY RIGHT IT MAY HAVE TO A TRIAL BY JURY IN RESPECT OF ANY LITIGATION DIRECTLY OR INDIRECTLY ARISING OUT OF, UNDER OR IN CONNECTION WITH THIS AGREEMENT OR ANY OTHER NOTE DOCUMENT. EACH PARTY HERETO (A) CERTIFIES THAT NO REPRESENTATIVE, AGENT OR ATTORNEY OF ANY OTHER PARTY HAS REPRESENTED, EXPRESSLY OR OTHERWISE, THAT SUCH OTHER PARTY WOULD NOT, IN THE EVENT OF LITIGATION, SEEK TO ENFORCE THE FOREGOING WAIVER AND (B) ACKNOWLEDGES THAT IT AND THE OTHER PARTIES HERETO HAVE BEEN INDUCED TO ENTER INTO THIS AGREEMENT BY, AMONG OTHER THINGS, THE MUTUAL WAIVERS AND CERTIFICATIONS IN SECTION 7.10 OF THE COLLATERAL AGREEMENT.




