ASSIGNMENT OF TRADEMARKS

This Assignment of Trademarks (this "Assignment of Trademarks") effective as of January 31, 2012, is entered by and among each of Evenflo Company, Inc., a Delaware corporation ("Evenflo"), Lisco Feeding, Inc., a Delaware corporation ("Lisco Feeding") and Lisco Furniture, Inc., a Delaware corporation ("Lisco Furniture") (each of Evenflo, Lisco Feeding and Lisco Furniture, an "Assignor" and collectively "Assignors") and Evenflo Company Holdings, LLC, a Delaware limited liability company ("Assignee").

WHEREAS, Assignors are the owners of those certain trademarks set forth in the attached <u>Schedule A</u> (the "Marks");

WHEREAS, Assignors, Kimberly-Clark de México, S.A.B. de C.V., a Mexico corporation ("KCM"), and the other parties thereto, are parties to that certain Purchase and Sale Agreement, dated as of January 13, 2012 (as amended and in effect from time to time, the "Purchase Agreement");

WHEREAS, pursuant to the Purchase Agreement, Evenflo has formed Assignee, a wholly-owned subsidiary of Evenflo; and

WHEREAS, pursuant to the Purchase Agreement, Assignee is acquiring from each Assignor, and each Assignor is transferring to Assignee all of such Assignor's right, title and interest in and to the Marks;

NOW THEREFORE, for good and valuable consideration as set forth in the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, each of the Assignors and Assignee hereby agree as follows:

- (i) <u>Conveyance and Acceptance</u>. Each Assignor hereby assigns, transfers and conveys to Assignee such Assignor's entire right, title and interest in and to the Marks, the goodwill of the business symbolized by the Marks, all registrations and applications for registration thereof, the right to sue, either at law or in equity and the right to recover for any past, present or future infringements thereof and the right to initiate other proceedings before all government and administrative bodies with respect to the Marks.
- (ii) <u>Further Action</u>. Each Assignor agrees, at Assignee's expense, to do all acts and take such further action, including the execution and acknowledgment of such additional documents as Assignee may reasonably request to carry out and fulfill the purposes and intent of this Assignment of Trademarks.

(iii) Miscellaneous.

- (a) This Assignment of Trademarks shall be binding upon and inure to the benefit of the parties hereto, and their permitted successors in interest and assigns.
- (b) This Assignment of Trademarks will be governed by and construed in accordance with the laws of the State of New York, without giving effect to any choice or

(c) This Assignment of Trademarks may be amended or modified only by a written instrument executed by all of the parties hereto.
