THIS FIRST LIEN TRADEMARK SECURITY AGREEMENT

THIS FIRST LIEN TRADEMARK SECURITY AGREEMENT, dated as of February 29, 2012, is made by each of the entities listed on the signature pages hereof (each a “Grantor” and, collectively, the “Grantors”), in favor of Credit Suisse AG, Cayman Islands Branch, (“Credit Suisse”), as administrative agent (in such capacity, together with its successors and permitted assigns, the “Administrative Agent”) and collateral agent (in such capacity, together with its successors and permitted assigns, the “Collateral Agent”), in each case, for the Lenders and the Secured Parties (each as defined in the First Lien Credit Agreement referred to below).

WITNESSETH:

WHEREAS, pursuant to the First Lien Term Loan Credit Agreement, dated as of February 29, 2012 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “First Lien Credit Agreement”), among DS Waters of America, Inc. (the “Borrower”), DS Waters Enterprises, Inc. (“Enterprises”), the Lenders from time to time party thereto and Credit Suisse, as Administrative Agent and Collateral Agent for the Lenders and the Secured Parties, the Lenders have severally agreed to make extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein;

WHEREAS, each Grantor (other than the Borrower) has agreed, pursuant to a First Lien Guaranty and Security Agreement of even date herewith in favor of the Agents (the “First Lien Guaranty and Security Agreement”), to guarantee the Obligations (as defined in the First Lien Credit Agreement) of the Borrower; and

WHEREAS, all of the Grantors are party to the First Lien Guaranty and Security Agreement pursuant to which the Grantors are required to execute and deliver this First Lien Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the Lenders and the Agents to enter into the First Lien Credit Agreement and to induce the Lenders to make their respective extensions of credit to the Borrower thereunder, the Grantor hereby agrees with the Collateral Agent as follows:

Section 1. Defined Terms. Capitalized terms used herein without definition are used as defined in the First Lien Guaranty and Security Agreement.

Section 2. Grant of Security Interest in Trademark Collateral. Each Grantor, as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Obligations of such Grantor, hereby mortgages, pledges as collateral and hypothecates to the Collateral Agent for the benefit of the Secured Parties, and grants to the Collateral Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the following Collateral of such Grantor (the “Trademark Collateral”):

(a) all of its trademarks, service marks, domain names, trade dress, logos, designs, slogans, trade names and other source identifiers, whether registered or unregistered, together, in each case, with the goodwill symbolized thereby ("Trademarks");

(b) all registrations and applications for registration for any Trademarks, including, without limitation, those registrations and applications for registration set forth on Schedule 1 hereto;

(c) all renewals and extensions of the foregoing;

(d) all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto; and

(e) all proceeds (as defined in the UCC) of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and all supporting obligations of, any and all of the foregoing, including, without limitation, any and all claims for damages and injunctive relief for past, present and future infringement, misappropriation or other violation with respect to any of the foregoing, with the right to sue for and collect, or otherwise recover, such damages.

Notwithstanding anything herein to the contrary, the Trademark Collateral shall not include any applications for Trademarks filed in the U.S. Patent and Trademark Office pursuant to 15 U.S.C. § 1051 Section 1(b) and for which a form evidencing use of the mark in interstate commerce has not been filed with the U.S. Patent and Trademark Office pursuant to 15 U.S.C. § 1051 Section 1(c) or 1(d).

Section 3. First Lien Guaranty and Security Agreement. The security interest granted pursuant to this First Lien Trademark Security Agreement is granted in conjunction, and concurrently, with the security interest granted to the Collateral Agent pursuant to the First Lien Guaranty and Security Agreement and each Grantor hereby acknowledges and agrees that the rights and remedies of the Collateral Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the First Lien Guaranty and Security Agreement. In the event of an irreconcilable conflict between the terms of this First Lien Trademark Security Agreement, the First Lien Guaranty and Security Agreement will govern.

Section 4. Grantor Remains Liable. Each Grantor hereby agrees that, anything herein to the contrary notwithstanding, such Grantor shall assume full and complete responsibility for the prosecution, defense, enforcement or any other necessary or desirable actions in connection with their Trademarks subject to a security interest hereunder.

Section 5. Recordation. Each Grantor authorizes and requests that the Register of Trademarks, the Commissioner for Patents and the Commissioner for Trademarks and any other Applicable IP Office in the United States of America record this First Lien Trademark Security Agreement.



Section 6. Intercreditor Agreement. The priority of the Lien granted to the Collateral Agent under this First Lien Trademark Security Agreement and the exercise of the rights and remedies of the Collateral Agent hereunder are subject to the provisions of the Intercreditor Agreement. In the event of any conflict between the terms of the Intercreditor Agreement and this First Lien Trademark Security Agreement, the terms of the Intercreditor Agreement shall govern and control.


Section 7. Counterparts. This First Lien Trademark Security Agreement may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart. Delivery of an executed signature page of this First Lien Trademark Security Agreement by facsimile transmission or by Electronic Transmission shall be as effective as delivery of a manually executed counterpart hereof unless a Requirement of Law requires that originals be delivered.

Section 8. GOVERNING LAW. THIS FIRST LIEN TRADEMARK SECURITY AGREEMENT AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HERETO SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.


