**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of February 29, 2012 in favor of DISPENSING DYNAMICS INTERNATIONAL (“Grantor”) by U.S. BANK NATIONAL ASSOCIATION (the “Administrative Agent”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Security Agreement and the IP Security Agreement (as defined below).

**WHEREAS**, pursuant to that certain Security Agreement by and between Perrin Manufacturing Company (predecessor in interest to Grantor) (“Perrin”), MFC Capital Funding Inc. (predecessor in interest to the Administrative Agent) (“MFC”) and the other parties thereto dated January 26, 2009 (the “Security Agreement”) and that certain Patent, Copyright, License and Trademark Security Agreement by and between Perrin, MFC and the other parties thereto dated January 26, 2009 (the “IP Security Agreement”), Perrin granted MFC a security interest in substantially all the assets of Perrin and, in connection therewith, entered into that certain Trademark Security Agreement dated January 26, 2009 (the “Trademark Security Agreement”) for the purpose of recording such security interest with respect to the Trademark Collateral (as defined in the Trademark Security Agreement), including those items set forth on Schedule A hereto, with the United States Patent and Trademark Office;

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on February 12, 2009, at Reel 003935, Frame 0405; and

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to the Administrative Agent.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby, on behalf of itself and the Lenders (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases any and all security interests it has against the Trademark Collateral (including, for the avoidance of doubt, those items set forth on Schedule A hereto), and (iii) re-assigns to Grantor any right, title and interest it may have in, to and under such Trademark Collateral.

The Administrative Agent shall, at Grantor’s expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
