Pursuant to the provisions of Section 48-21-111 of the Tennessee Business Corporation Act, as amended (the "Act"), and Section 48-249-703 of the Tennessee Revised Limited Liability Company Act, as amended (the "LLC Act"), the undersigned hereby submits this certificate of conversion:

FIRST: The name of the converting domestic corporation is Lochinvar Corporation (the "Corporation").

SECOND: The principal business address of the Corporation is 300 Maddox Simpson Parkway, Lebanon, Tennessee, 37097.

THIRD: The Corporation was incorporated in the State of Tennessee on May 6, 1991 and its Secretary of State control number is 000240155.

FOURTH: The Corporation does now wish to convert from a corporation to a domestic limited liability company, and the name of the domestic limited liability company as set forth in the Articles of Organization, filed contemporaneously herewith, is Lochinvar, LLC (the "LLC").

FIFTH: The Plan of Conversion is attached hereto as Exhibit A and is incorporated by reference.

SIXTH: The terms and conditions of the conversion of the Corporation into the LLC have been approved by the unanimous vote of the shareholders and the directors of the Corporation in accordance with Sections 48-17-104 and 48-18-202 of the Act.

SEVENTH: The number of members of the LLC at the date of conversion is one (1).

EIGHTH: The effective date and time of the conversion of the Corporation into the LLC shall be upon filing this Certificate of Conversion.

This Plan of Conversion (the "Plan"), dated August 26, 2011, is adopted for the purpose of converting Lochinvar Corporation, a Tennessee corporation (the "Corporation"), to a Tennessee limited liability company (the "Conversion").

1. Certificate of Conversion. The Corporation shall cause to be filed with the Secretary of State of the State of Tennessee a Certificate of Conversion in the form attached hereto as Exhibit A (the "Certificate of Conversion"), pursuant to the requirements of Section 48-249-703 of the Tennessee Limited Revised Liability Company Act, as amended (the "LLC Act") and the requirements of Section 48-21-111 of the Tennessee Business Corporation Act, as amended (the "Act").

2. Name of Limited Liability Company. The name of the limited liability company to be formed pursuant to such conversion is Lochinvar, LLC (the "LLC").

3. Conversion of Shares. Simultaneously with the filing of the Certificate of Conversion described above, the outstanding capital stock of the Corporation's shareholders shall be converted into 100% of the membership interests in the LLC.

4. Effective Date. The effective date and time of the conversion shall be upon filing the Certificate of Conversion.

5. Articles of Organization. The organizer of the LLC shall cause to be filed with the Secretary of the State of the State of Tennessee, the Articles of Organization, in the form attached hereto as Exhibit B (the "Articles of Organization").

6. Operating Agreement. Notification from the Secretary of State of the State of Tennessee of the approval of the conversion will be deemed to be execution by the sole member of the LLC of the Limited Liability Company Operating Agreement of the LLC (the "Operating Agreement").

7. Surrender of Certificates. Promptly following the filing of the Certificate of Conversion and the conversion of shares, as set forth in Sections 1 and 3 hereof, the stockholder holding shares of stock in the Corporation shall be required to surrender to the Corporation its certificate or certificates representing the outstanding voting shares of stock held by such stockholders, and its interest shall be deemed to have been converted to a Membership Interest and Membership Percentage in the LLC, as those terms are defined in the Operating Agreement.

8. Governing Law. This Plan shall be governed by, and interpreted in accordance with, the laws of the State of Tennessee, particularly including, but not limited to, the LLC Act and Act.


