TRADEMARK SECURITY AGREEMENT MADE BY COLMAN IN FAVOR OF ADMINISTRATIVE AGENT

THIS TRADEMARK SECURITY AGREEMENT (this "<u>Agreement</u>"), dated as of February 29, 2012, is made by **The Colman Group, Inc.**, a Wisconsin corporation (the "<u>Company</u>") in favor of **U.S. Bank National Association**, a national banking association, as administrative agent (in such capacity, the "<u>Administrative Agent</u>") for the lenders from time to time party to the Credit Agreement referred to below (the "<u>Lenders</u>").

RECITALS

WHEREAS, Dispensing Dynamics International ("DDI"), the Lenders and the Administrative Agent have entered into a Credit Agreement dated as of February 29, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), pursuant to which the Lenders have agreed to make certain loans to the Company;

WHEREAS, the Company, DDI, DDI Group, LLC, a Delaware limited liability company ("<u>DDI Group</u>"), San Jamar – Chef Revival EMEA, Inc., a Wisconsin corporation ("<u>Chef Revival</u>"), San Jamar Mexico, LLC, a Wisconsin limited liability company ("<u>San Jamar Mexico</u>"), and San Jamar – Chef Revival Canada, Inc., a Wisconsin corporation ("<u>San Jamar Canada</u>") (collectively, the "<u>Obligors</u>") and the Administrative Agent have entered into a Pledge and Security Agreement dated as of February 29, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the "<u>Security Agreement</u>"); and

WHEREAS, pursuant to the terms of the Security Agreement, the Company has granted to the Administrative Agent, for the benefit of itself and the Lenders, security interest in substantially all the assets of the Company, including all right, title and interest of the Company in, to and under all now existing and hereafter arising service marks, trademarks, trademark or service mark registrations, trademark or service mark applications and trade names, all renewals thereof, all income, royalties, damages and payments now and hereafter due and/or payable with respect thereto arising in favor of the Company, and the goodwill of the Company's business connected with and symbolized thereby, to secure the payment and performance in full of all amounts owing by the Company under the Credit Agreement and the other Loan Documents (as defined in the Credit Agreement);

NOW, THEREFORE, in consideration of the mutual agreements set forth herein and in the Credit Agreement, the Company hereby grants to the Administrative Agent, for the benefit of itself and the Lenders, security interest in all of the Company's right, title and interest in and to the following, whether now existing and hereafter arising:

(1) each trademark and trademark application, including, without limitation, each trademark and trademark application referred to in <u>Schedule 1</u> annexed hereto, and all renewals thereof, together with the goodwill of the Company's business connected with and symbolized thereby;

- all license agreements with any other Person or Persons with respect to any service marks, trademarks, trademark or service mark registrations, trademark or service mark applications and trade names, whether the Company is a licensor or licensee under any such license agreements, and, subject to the terms of such licenses, the right to prepare for sale, sell and advertise for sale, all inventory now or hereafter owned by the Company and now or hereafter covered by such licenses unless, but only for so long as, the grant of such security interest shall constitute or result in a breach, termination or default under any of the foregoing, other than to the extent that any such breach would be rendered ineffective pursuant to Section 9-406, 9-407, 9-408 or 9-408 of the New York UCC; and
- (3) all products and proceeds of the foregoing, including, without limitation, all income, royalties, damages and payments now and hereafter due and/or payable with respect thereto arising in favor of the Company (items 1 through 3 being herein collectively referred to as the "<u>Trademark Collateral</u>");

<u>provided</u>, <u>however</u>, that there shall be excluded from the foregoing grant of security interest all Excluded Property (as such term is defined in the Security Agreement).

This Agreement shall terminate and the security interest in the Trademark Collateral shall be released upon the payment and performance in full of all amounts owing by the Company under the Credit Agreement and the other Loan Documents. Upon the termination of this Agreement, the Administrative Agent shall execute all documents, make all filings, take all other actions reasonably requested by the Company to evidence and record the release of the security interest in the Trademark Collateral granted herein.

This security interest is granted in conjunction with the security interests granted to the Administrative Agent pursuant to the Security Agreement and is subject to limitations set forth therein. In the event of any conflict between any provision of this Agreement and any provision of the Security Agreement, the Security Agreement will govern. Each of the Company and the Administrative Agent hereby acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Credit Agreement and the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

This Agreement shall be construed in accordance with the internal laws (without regard to the conflict of laws provisions) of the State of New York, but giving effect to federal laws applicable to national banks.
