# FIRST AMENDMENT TO SECURITY AGREEMENT AND COLLATERAL ASSIGNMENT OF TRADEMARKS

THIS FIRST AMENDMENT TO SECURITY AGREEMENT AND COLLATERAL ASSIGNMENT OF TRADEMARKS ("this Amendment") dated March 6, 2012 is entered into by and among MAYER ELECTRIC SUPPLY COMPANY, INC., a Delaware corporation ("Mayer"); and REGIONS BANK, an Alabama banking corporation, in its capacity as collateral and administrative agent for certain lenders under the Loan Agreement (as defined below) (together with its successors in such capacity, "Agent").

## RECITALS

- A. Mayer, other borrower parties and Agent are parties to that certain Security Agreement and Collateral Assignment of Trademarks dated as of October 31, 2005 (the "Security Agreement"), executed in connection with that certain Loan and Security Agreement dated as of October 31, 2005, as amended from time to time (the "Original Loan Agreement").
- B. Mayer has requested that Agent extend the maturity of and make other modifications to the Original Loan Agreement and Agent has agreed to such extension and modifications, subject to the terms and conditions set forth in that certain Amended and Restated Loan and Security Agreement dated of even date herewith (the "Loan Agreement").
- C. In connection with the Loan Agreement, Mayer and Agent have agreed to make certain modifications to the Security Agreement as more specifically set forth herein this Amendment.

#### AGREEMENT

NOW, THEREFORE, in consideration of the foregoing recitals and in further consideration of the mutual agreements set forth herein, Mayer and Agent hereby agree as follows:

- 1. <u>Rules of Construction</u>. This Amendment is subject to the rules of construction set forth in the Loan Agreement.
- **2.** <u>Definitions</u>. Capitalized terms used in this Amendment and not otherwise defined herein have the meanings defined for them in the Loan Agreement.
- 3. <u>Amendments to Security Agreement</u>. Paragraphs 2 and 3 of Schedule A to the Security Agreement are hereby deleted in their entirety and replaced with paragraphs 2 and 3 set forth on Schedule A attached to this Amendment.

## 4. Miscellaneous.

(a) Except as amended hereby, the Security Agreement shall continue in full force and effect.

- (b) Mayer hereby represents and warrants to Agent that all representations and warranties contained in the Security Agreement are true and correct as of the date hereof (except representations and warranties that are expressly limited to an earlier date); and Mayer hereby certifies that no Event of Default nor any event that, upon notice or lapse of time or both, would constitute an Event of Default, has occurred and is continuing.
- (c) This Amendment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which when taken together shall constitute one and the same instrument.
- (d) The covenants and agreements contained herein shall apply to and inure to the benefit of and be binding upon the parties hereto and their respective successors and permitted assigns.
- (e) Nothing contained herein shall be construed as a waiver, acknowledgment or consent to any breach of or Event of Default under the Security Agreement and other related documents not specifically mentioned herein, and the consents granted herein are effective only in the specific instance and for the purposes for which given.
  - (f) This Amendment shall be governed by the laws of the State of Alabama.
