AGREEMENT OF MERGER OF DIRECTV, INC. WITH AND INTO DIRECTV, LLC

This Agreement of Merger, dated as of December 2011 (this "Agreement"), is entered into by and between DIRECTV, Inc., a California corporation ("Company One"), and DIRECTV, LLC, a California limited liability company ("Company Two") in accordance with the California Corporations Code, and the Beverly-Killea Limited Liability Company Act.

RECITALS:

WHEREAS, the Board of Directors of Company One and the sole member of Company Two deem it advisable and in their respective best interests that Company One be merged with and into Company Two (the "Merger") at the Effective Time (as defined below);

WHEREAS, the Board of Directors of Company One, on behalf of Company One, and the sole member of Company Two have approved the Merger, subject to the approval of the sole shareholder of Company One; and

WHEREAS, this Agreement has been submitted and approved by the sole shareholder of Company One which agrees that the Merger is advisable and in the best interest of Company One.

NOW, THEREFORE, in consideration of the foregoing premises and the covenants and agreements contained herein, and intending to be legally bound hereby, Company One and Company Two hereby agree as follows:

AGREEMENT

SECTION 1. <u>Effective Time</u>. The Merger shall become effective on January 1, 2012 at 12:01 am local time in the jurisdiction of incorporation and formation.

SECTION 2. <u>Surviving Company</u>. At the Effective Time, Company One shall be merged with and into Company Two and Company Two shall survive the Merger (the "Surviving Entity"). At the Effective Time, the separate existence of Company One shall cease and the Surviving Entity shall succeed, without other transfer, act or deed, to all of the rights and property, whether real or personal, of Company One and shall be subject to all the debts and liabilities of Company One in the manner as if the Surviving Entity had itself incurred them.

This Agreement may only be amended by a written instrument signed on behalf of each of the parties hereto.

SECTION 7. <u>Termination</u>; <u>Abandonment</u>. The Board of Directors of Company One and the sole member of Company Two may terminate this Agreement and abandon the Merger, subject to the contractual rights of third parties, if any, including the other parties to this Agreement, at any time before the Effective Time.

SECTION 8. <u>Miscellaneous</u>. This Agreement may be executed in counterparts, each of which shall be deemed an original and all of which shall be deemed one and the same instrument.
