TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "**Agreement**") is made and entered into as of February 1, 2012 (the "**Effective Date**") by and between Rovi Corporation, a Delaware corporation and its wholly-owned subsidiary Sonic Solutions LLC, a California limited liability company (each individually, "**Assignor**," and collectively, "**Assignors**") and Corel Corporation, a Canadian corporation ("**Assignee**").

WHEREAS, Assignors and Assignee are parties to that certain Asset Purchase Agreement, dated January 12, 2012, as amended by that certain Amendment No. 1 to Asset Purchase Agreement of even date herewith (as amended, the "**Purchase Agreement**"), pursuant to which Assignors have agreed to sell, assign, transfer, convey, and deliver to Assignee certain assets, including, without limitation, the Assigned Marks (defined below); and

WHEREAS, pursuant to the Purchase Agreement, Assignors and Assignee have agreed to enter into this Agreement.

NOW, THEREFORE, in consideration of the promises and covenants set forth in the Purchase Agreement and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Assignment. Each Assignor hereby assigns, transfers, conveys and delivers to Assignee, and Assignee does hereby accept from Assignors, all right, title and interest in, to and under the trademarks, service marks, trademark registrations, service mark registrations, trademark applications and service mark applications set forth on the Exhibit A and all goodwill associated therewith, and rights to sue or make any claims for any past, present or future infringement, misappropriation or unauthorized use of any of the foregoing and the right to all damages and other payments that are now or may hereafter become due or payable with respect to any of the foregoing after the Closing Date (as defined in the Purchase Agreement) (the "**Assigned Marks**").

2. Recordation and Issuance. Assignors hereby request the United States Patent and Trademark Office Commissioner for Trademarks and any other applicable governmental entity or registrar (including any applicable foreign or international office or registrar), to record Assignee as the assignee and owner of the Assigned Marks. Assignors hereby authorize and request the officials of all countries in which any of the Assigned Marks is now or will in the future be issued to issue to Assignee all of each Assignor's right, title and interest in and to the same, for the sole use and enjoyment of Assignee.

3. Further Assurances. Upon Assignee's request and at Assignee's sole expense, Assignors shall execute, acknowledge and deliver all such other instruments and documents and

shall take all such other actions Assignee may request to consummate, evince or make fully effective the transaction contemplated by this Agreement.

4. Governing Law. This Agreement will be governed by and construed in accordance with the law of State of California without regard to the choice of law principles thereof.

5. Amendment. This Agreement may be amended only by an instrument in writing signed by both parties hereto.

6. Counterparts. This Agreement may be executed in counterparts, each of which shall be deemed to be an original, and all such counterparts when taken together shall constitute one and the same instrument.

7. Purchase Agreement Controls. This Agreement is provided pursuant to the Purchase Agreement, to which reference is made for a further statement of the rights and obligations of Assignors and Assignee with respect to the Assigned Marks. Nothing contained in this Agreement shall be deemed to modify, supersede, enlarge or affect the rights of any person under the Purchase Agreement. If any provision of this Agreement is inconsistent or conflicts with the Purchase Agreement, the Purchase Agreement shall control.
