#### TRADEMARK SECURITY AGREEMENT

This **TRADEMARK SECURITY AGREEMENT** dated as of March 23, 2012, is entered into by and among each of the signatories hereto (together with any other entity that may become a party hereto as provided herein, the "<u>Grantors</u>") in favor of BARCLAYS BANK PLC, as administrative agent for the benefit of Secured Parties (in such capacity and together with its successors in such capacity, the "<u>Administrative Agent</u>") (as may hereafter be amended, supplemented, amended and restated, replaced or otherwise modified, the "Agreement").

WHEREAS, pursuant to the Term Loan Agreement, dated as of the date hereof (as amended, restated, supplemented, replaced or otherwise modified from time to time, the "Loan Agreement"), among Anchor Hocking, LLC, a Delaware limited liability company, as Borrower Agent ("Anchor"), Oneida Ltd., a Delaware corporation ("Oneida" and together with Anchor, each individually a "Borrower" and collectively, "Borrowers"), Universal Tabletop, Inc., a Delaware corporation ("Holdings"), the Administrative Agent and each of the financial institutions party thereto from time to time, as lenders (the "Lenders"), the Lenders have severally agreed to make extensions of credit to Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, to secure the payment and performance of the Borrowers' obligations under the Loan Agreement and the other Loan Documents and to continue to make loans and advances and provide other financial accommodations to Borrowers pursuant thereto, Grantors have agreed, pursuant to the Guarantee and Collateral Agreement, dated as of the date hereof, among Borrowers, Holdings and the other Grantors party thereto from time to time (as may hereafter be amended, supplemented, amended and restated, replaced or otherwise modified, the "Collateral Agreement"), to execute and deliver to Administrative Agent this Agreement; and

WHEREAS, under the terms of the Collateral Agreement, Grantors have granted a security interest in certain property, including, without limitation, certain Intellectual Property of Grantors to Administrative Agent for the ratable benefit of Secured Parties, and have agreed as a condition thereof to execute this Agreement for recording with the United States Patent and Trademark Office and other applicable Governmental Authorities.

**NOW, THEREFORE**, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Grantors and Secured Parties hereby agree as follows:

SECTION 1. <u>DEFINED TERMS</u>. Capitalized terms not otherwise defined herein have the meanings set forth in the Loan Agreement.

SECTION 2. GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL. Each Grantor hereby grants to Administrative Agent, for the benefit of Secured Parties, a first priority security interest in and continuing first lien on all of such Grantor's right, title, and interest in, to and under the following, whether now owned or existing or hereafter acquired or arising and wherever located (collectively, the "Trademark Collateral"):

- (a) all trademarks, service marks, trade names, trademark and service mark applications and registrations, including, without limitation, those trademarks, service marks, trade names, and trademark and service mark applications and registrations listed on Schedule A,
  - (b) all extensions, renewals, and reissues of any of the foregoing,
  - (c) all licenses of any of the foregoing,
  - (d) all goodwill associated with or symbolized by of any of the foregoing,
- (e) all rights to sue for past, present, and future infringement of any of the foregoing, and
  - (f) all corresponding rights thereto throughout the world.

Notwithstanding the foregoing, the Trademark Collateral shall not include any trademark applications filed on an intent-to-use basis, and no security interest in and lien on such applications shall be deemed granted hereby, until such time, if any, as a statement of use is filed and accepted by the United States Patent and Trademark Office.

SECTION 3. <u>PRECEDENCE</u>. The security interest granted hereby is granted in conjunction with the security interest granted to Secured Parties under the Loan Agreement. The rights and remedies of Secured Parties with respect to the security interest granted hereby are in addition to those set forth in the Loan Agreement. In the event of any conflict between the terms of this Agreement and the terms of the Loan Agreement, the terms of the Loan Agreement shall control.

SECTION 4. <u>RECORDATION</u>. Each Grantor authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Agreement.

SECTION 5. <u>RELEASE OF SECURITY AGREEMENT</u>. Upon (i) the sale, transfer or other disposition of any Trademark Collateral in accordance with the Loan Agreement or (ii) the Termination Date, Administrative Agent shall execute and deliver to Grantors all instruments and other documents as may be necessary or proper to release the lien on and security interest in the Trademark Collateral which has been granted hereunder.

SECTION 6. MODIFICATION OF AGREEMENT. This Agreement or any provision hereof may not be changed, waived, or terminated except in accordance with the amendment provisions of the Loan Agreement pursuant to which Administrative Agent may modify this Agreement, after obtaining Grantors' approval, by amending Schedule A to include reference to any right, title or interest in any existing Trademarks or any Trademarks acquired or developed by Grantors after the execution hereof or to delete any reference to any right, title or interest in any Trademarks in which Grantors no longer have or claim any right, title or interest.

SECTION 7. GENERAL.
