RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

This RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST (the "Release") is made as of March 14, 2012 by WELLS FARGO CAPITAL FINANCE, INC. (formerly known as WELLS FARGO FOOTHILL, INC.), a California corporation, as arranger and administrative agent (in such capacity, the "Agent") for the lenders identified in the Credit Agreements (together with their respective successors and assigns) (collectively, the "Lenders").

WITNESSETH:

WHEREAS, pursuant to a Loan and Security Agreement dated August 5, 2003, OSC Acquisition, LLC, a Delaware limited liability company, granted to the Agent and Lenders (collectively, the "Lender Group") a security interest to the Trademarks and Trade Secrets, Copyrights and Patents respectively under a Trademark Security Agreement, Copyright Security Agreement, and Patent Security Agreement, separately executed by the parties on August 5, 2003;

WHEREAS, OSC Acquisition, LLC changed its name from OSC Acquisition, LLC to Ontario Systems, LLC on September 15, 2003;

WHEREAS, pursuant to an Amended and Restated Credit Agreement dated as of June 11, 2008, OSC Holdings, LLC, a Delaware limited liability company and Ontario Systems, LLC (collectively, the "Grantors") granted to the Lender Group a security interest to the Trademarks and Trade Secrets, Copyrights, and Patents respectively under a Trademark Security Agreement, Copyright Security Agreement, and Patent Security Agreement, separately executed by the parties on June 11, 2008;

WHEREAS, the Loan and Security Agreement dated August 5, 2003 and the Amended and Restated Credit Agreement dated June 11, 2008 are collectively referred to as the "Credit Agreements" and the respective Trademark Security Agreements, Copyright Security Agreements, and Patent Security Agreements executed by the parties pursuant to those Credit Agreements are collectively referred to as the "Security Interest Agreements"; and

WHEREAS, the Credit Agreements and the Security Agreements were terminated on July 8, 2011.

NOW THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent on behalf of each member of the Lender Group confirms and agrees to the following:

- 1. Release. On behalf of each member of the Lender Group, the Agent hereby confirms that the Security Interest Agreements and all rights granted to the Lender Group have been terminated. Further, on behalf of each member of the Lender Group, the Agent hereby fully waives and fully releases all of the Lender Group's right, title and interest in any continuing security interest and collateral assignment in the intellectual property, including without limitation the following:
- (a) <u>Patents</u>. The entire right, title and interest in and to the patent applications and patents listed in <u>Exhibit A</u> hereto, including without limitation all proceeds

thereof (such as, by way of example, license royalties or proceeds obtained from infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto, throughout the world and all reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof (collectively, the "Patents").

- (b) <u>Patent Licenses</u>. All licenses or other agreements, including, but not limited to those listed in <u>Exhibit A</u> hereto, entered into with any other person in connection with the Patents or any other person's patents, patent applications, or patent rights and all tangible property covered by any such agreement, whether Grantors are a licensor or licensee under any such agreement.
- (c) <u>Copyrights</u>. All worldwide copyrights registrations (all renewals and extensions thereof), all worldwide copyright applications, and all title, right and interest in all works subject to copyright protections owned by the Grantors, including, but not limited to: (i) all copyrights, distribution rights and any and all other rights or interests in the copyright registrations listed in <u>Exhibit B</u>; (ii) all works based upon, incorporated in, derived from, incorporating or relating to all works subject to copyright protection; (iii) all tangible property embodying the copyrighted materials; and (iv) any and all proceeds of the foregoing, including without limitation, license royalties and proceeds obtained from infringement suits, and the right to sue for past, present and future infringements (collectively, the "Copyrights").
- (d) <u>Copyright Licenses</u>. All licenses or other agreements entered into with any other person in connection with the Copyrights or any other person's registered copyrights or copyrighted works and all tangible property covered by any such agreement, whether Grantors are a licensor or licensee under any such agreement.
- (e) Trademarks and Trade Secrets. The entire right, title and interest in and to: (i) the trademarks, trademark registrations, and applications for trademark registration listed in Exhibit C, including without limitation all proceeds thereof (such as, by way of example, license royalties or proceeds obtained from infringement suits), all renewals thereof, the right to sue for past, present and future infringements and all rights corresponding to the trademarks throughout the world; (ii) trade secrets, proprietary or confidential information, technical information procedures, formulae, quality control standards, design, operating and training manuals, and customer lists; and (iii) all goodwill of the business, products and services of the Grantors connected with the use of each of the listed trademarks (collectively, the "Trademark and Trade Secrets").
- (f) <u>Trademark Licenses</u>. All licenses or other agreements entered into with any other person in connection with the Trademarks and Trade Secrets or any other person's trademarks or trade secrets and all tangible property covered by any such agreement, whether Grantors are a licensor or licensee under any such agreement.
- 2. Agent represents that it has the full power and authority to execute this Release on behalf of each member of the Lender Group.


