ASSIGNMENT OF INTELLECTUAL PROPERTY SECURITY AGREEMENT dated as of the fourth day of April, 2012 and effective as of 4:00 p.m. (New York time) on April 4, 2012 (the “Assignment”), by BEAL BANK, SSB (the “Assignor”), to ICAHN AGENCY SERVICES, LLC (the “Assignee”).


