**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This TERMINATION AND RELEASE, dated as of April 5, 2012, is made by Bank of America, N.A., as administrative agent (the "Agent") for itself and the several banks and other financial institutions or entities (the "Lenders") from time to time parties to the Credit Agreement, dated as of September 30, 2010 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Alliance Laundry Holdings LLC, Alliance Laundry Systems LLC (the "Company"), the Agent, the Lenders and the other parties thereto.

**W I T N E S S E T H**

1. The Agent, hereby terminates, releases and discharges its security interest in the Trademark Collateral, and all of its right, title and interest in and to the security interests granted to Agent in the Trademark Collateral pursuant to the Security Agreements.
2. The Agent agrees to execute and deliver and provide Company with any information and additional authorization and take all other actions necessary or

reasonably desirable to effect the release of the Agent's security interest in the released Trademark Collateral.
