

RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is made as of April 30, 2012 (the "Effective Date") by Bank of America, N.A., as administrative agent (in such capacity, the "Agent") for the benefit of Milacron LLC and DME Company LLC (individually, a "Pledgor", and, collectively, the "Pledgors").

If and to the extent the Agent has acquired any right, title or interest in or to any of the Trademarks, it hereby irrevocably assigns and transfers all such rights, title and interest to their respective Pledgors.

The Agent shall take all further actions, and provide to the Pledgors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgors to more fully and effectively effectuate the purposes of this Release.
