**TRADEMARK RELEASE**

This release of security interest in United States trademarks (this "Release"), effective as of April 30, 2012, is granted by Morgan Stanley Senior Funding, Inc., with principal offices at 1 Pierrepont Plaza, Brooklyn, NY 11201, in its capacity as Bridge Collateral Agent for and on behalf of the Secured Creditors (the "Collateral Agent"), to CF Industries, Inc., a Delaware corporation with principal offices at 4 Parkway North, Suite 400, Deerfield, IL 60015-2590 (the "Grantor"), as follows:

**W I T N E S S E T H:**

WHEREAS, pursuant to the terms of the Guaranty and Collateral Agreement, dated as of April 5, 2010, by and among the Grantor, the Collateral Agent and the other parties thereto (as amended, modified, restated and/or supplemented from time to time, the "Guaranty and Collateral Agreement") and the Grant of Security Interest in United States Trademarks, dated April 5, 2010, by and between the Grantor and the Collateral Agent (with the Guaranty and Collateral Agreement, the "Security Documents"), the Grantor has heretofore granted to the Collateral Agent a security interest in (i) all of the Grantor's right, title and interest in, to and under the United States trademark registrations and trademark applications (the "Marks") set forth on Schedule A attached hereto, other than any "intent-to-use" applications for Marks unless and until an Amendment to Allege Use or Statement of Use has been filed with and accepted by the United States Patent and Trademark Office ("PTO") only if and to the extent that the grant of a security interest therein would adversely affect the validity of the mark, (ii) all Proceeds and products of the Marks and (iii) the goodwill of the businesses associated with or symbolized by the Marks (collectively, the "Trademark Collateral"), which security interest was recorded on April 12, 2010 at Reel 4184, Frame 0307 in the PTO; and

WHEREAS, the Collateral Agent wishes to (i) release its security interest in the Trademark Collateral, (ii) restore its right, title and interest in and to the Trademark Collateral to the Grantor and (iii) dissolve any and all liens and encumbrances respecting the Trademark Collateral under the Security Documents.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

The Collateral Agent hereby terminates, releases, discharges fully, quit claims and relinquishes unto the Grantor its security interest in and lien on the Trademark Collateral, and reassigns and transfers to the Grantor any and all right, title and interest that the Collateral Agent may have in, to or under the Trademark Collateral, in each case, without recourse and without representation or warranty of any kind (implied or express). All capitalized terms used but not defined in this Release shall have the meanings ascribed to them in the Guaranty and Collateral Agreement.


The Collateral Agent hereby authorizes the Grantor or the Grantor's authorized representative to (i) record this Release with the PTO and/or (ii) otherwise record or file this Release in any other applicable governmental office or agency in order to provide notice of the release of any security interest of the Collateral Agent in the Trademark Collateral.

This Release shall be construed in accordance with and governed by the laws of the State of New York.


