AMENDED AND RESTATED GRANT OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS

Amended and Restated Grant of Security Interest in United States Trademarks, dated as of May 8, 2012 (this "Agreement"), by and between PERFORMANCE FOOD GROUP, INC. (f/k/a Vistar Corporation), a corporation formed under the laws of Colorado (the "Grantor"), in favor of WELLS FARGO BANK, NATIONAL ASSOCIATION (successor by merger to Wachovia Bank, National Association), in its capacity as Collateral Agent (the "Grantee").

WITNESSETH:

WHEREAS, pursuant to the Credit Agreement dated as of May 23, 2008, by and among Vistar Corporation, Vistar Management, Inc., Wachovia Bank, National Association and the other Lenders party thereto (as amended, restated, supplemented, or otherwise modified from time to time, including as amended and restated on May 8, 2012, the "Credit Agreement"), the Grantor and other subsidiaries thereto entered into a Security Agreement on May 23, 2008 (as amended and restated from time, including as amended and restated on May 8, 2012, the "Security Agreement") in favor of Wachovia Bank, National Association;

WHEREAS, pursuant to the Security Agreement, the Grantor and other subsidiaries party thereto entered into a Trademark Security Agreement on May 23, 2008 (the "Trademark Security Agreement"), whereby the Grantor pledged and granted to Wachovia Bank, National Association, for the benefit of the Secured Parties, a lien on and security interest in and to all of its right, title and interest in, to and under all the Trademarks of the Grantor, including without limitation, those items listed on Schedule I attached hereto and all Proceeds of any and all of the foregoing (the "Security Interest");

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on May 29, 2008, at Reel 3786 and Frames 0203, 0115 and 0187; and on June 13, 2008, at Reel 3795 and Frames 0866 and 0937;

WHEREAS effective on March 28, 2009, All Kitchens, LLC merged with and into Progressive Group Alliance, LLC and Plee-Zing, Inc. merged with and into Progressive Group Alliance, LLC, with Progressive Group Alliance, LLC as the surviving entity in both mergers;

WHEREAS effective on November 10, 2010, Performance Food Group Company, LLC changed its name to PFG Holdings, LLC;

WHEREAS effective on January 27, 2012, Progressive Group Alliance, LLC merged with and into the Grantor and PFG Holdings, LLC merged with and into the Grantor, with the Grantor as the surviving entity in both mergers;

WHEREAS the Grantee succeeded by merger to Wachovia Bank, National Association;

WHEREAS the Grantor and the Grantee wish to amend and restate the Security Interest granted under the Trademark Security Agreement;

Now, THEREFORE, in consideration of the premises and to induce the Grantee, for the

benefit of the Secured Parties, to enter into the Credit Agreement, the Grantor hereby agrees with the Grantee as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

SECTION 2. Amendment and Restatement of Grant of Security Interest in Trademark Collateral. The Grantor and the Grantee hereby amend and restate the Security Interest and the Grantor confirms the pledge and grant to the Grantee for the benefit of the Secured Parties of a lien on and security interest in and to all of its right, title and interest in, to and under all the Trademarks of the Grantor including, without limitation, those items listed on Schedule I attached hereto, and all Proceeds of any and all of the foregoing; provided that with respect to any Trademarks, applications in the United States Patent and Trademark Office to register Trademarks on the basis of any Grantor's "intent-to-use" such Trademarks will not be deemed to be Collateral unless and until a "Statement of Use" or "Amendment to Allege Use" has been filed and accepted in the United States Patent and Trademark Office, whereupon such application shall be automatically subject to the Security Interest and deemed to be included in the Collateral.

SECTION 3. Security Agreement. The Security Interest amended and restated herein is granted in connection with the Security Agreement and is expressly subject to the terms and conditions thereof. Grantor hereby acknowledges and affirms that the rights and remedies of the Grantee with respect to the Security Interest in the Trademarks are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. The Security Agreement (and all rights and remedies of the Lenders thereunder) shall remain in full force and effect in accordance with its terms. In the event that any provision of this Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control.

SECTION 4. Purpose. This Agreement has been executed and delivered by the Grantor for the purpose of recording the amendment and restatement of the Security Interest herein with the United States Patent and Trademark Office.

SECTION 5. Termination. Upon the payment in full of the Obligations and termination of the Security Agreement, the Grantee shall, at the reasonable request of the Grantor, execute, acknowledge, and deliver to the Grantor an instrument in writing in recordable form releasing the collateral pledge, grant, lien and security interest in the Trademarks listed on Schedule I attached hereto.


