RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of May 15, 2012 granted by Bank of America, N.A., in its capacity as administrative agent (the “Administrative Agent”) pursuant to that certain Credit Agreement dated as of May 24, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”) among Wendy’s/Arby’s Restaurants, LLC, a Delaware limited liability company, the lenders and other parties thereto from time to time and the Administrative Agent (capitalized terms used herein have the meanings attributed thereto in the Credit Agreement unless otherwise defined herein) in favor of Oldemark LLC (“Oldemark”) and Wendy’s International, Inc. (“Wendy’s”, collectively with Oldemark, the “Grantors”).

WHEREAS, pursuant to the terms and conditions of that certain Security Agreement dated as of May 24, 2010, among the Administrative Agent, the Grantors and the other parties thereto (as amended, supplemented or otherwise modified, the “Security Agreement”), the Grantors granted and pledged to the Administrative Agent a continuing security interest in and to the Collateral, as collateral security for the payment and performance in full when due of the Obligations;

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement dated as of May 24, 2010 (as amended, supplemented or otherwise modified, the “2010 Trademark Security Agreement”), among the Grantors, the other parties thereto and the Administrative Agent, and that certain Trademark Security Agreement dated as of March 7, 2011 (as amended, supplemented or otherwise modified, the “2011 Trademark Security Agreement”, and together with the 2010 Trademark Security Agreement, the “Intellectual Property Security Agreements”), among Oldemark, the other parties thereto and the Administrative Agent, the Grantors pledged to the Administrative Agent a continuing security interest in all of its right, title and interest in certain Collateral including, without limitation, the trademark registrations and applications set forth on Schedule I hereto together with the goodwill associated therewith (collectively, the “Trademarks”);

WHEREAS the 2010 Trademark Security Agreement has been recorded with the Trademarks Division of the United States Patent and Trademark Office on May 27, 2010 at Reel 004213 and Frame 0970;

WHEREAS the 2011 Trademark Security Agreement has been recorded with the Trademarks Division of the United States Patent and Trademark Office on March 11, 2011 at Reel 004495 and Frame 0932; and

NOW, THEREFORE, in acknowledgement that the Obligations have been repaid in full, the Administrative Agent hereby terminates the Security Agreement and each of the Intellectual Property Security Agreements insofar as it relates to the Trademarks, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademarks, together with the goodwill associated with such Trademarks, and all Proceeds (as defined in the Security Agreement) of any and all of the foregoing, without warranty or recourse.

If and to the extent the Administrative Agent has acquired any right, title or interest to any of the Trademarks, it hereby assigns and transfers such rights, title or interest to the applicable Grantor.

The Administrative Agent shall take all further actions, and provide to each Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including,

without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Grantor to more fully and effectively effectuate the purposes of this Release.

This Release shall be construed in accordance with and governed by the law of the State of New York.
