AND, ASSIGNOR hereby binds itself, its heirs, legal representatives, administrators and assigns properly to execute without further consideration any and all applications, petitions, oaths, assignments or other papers and instruments which may be necessary in order to carry into full force and effect the sale, assignment, transfer and conveyance hereby made or intended to be made and generally do everything

possible to aid ASSIGNEE, its legal representatives and assigns to obtain and enforce proper protection for said trademarks.

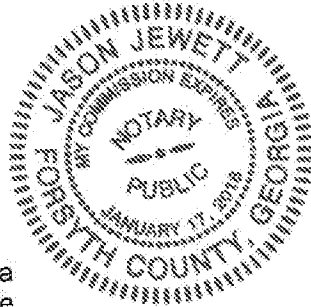
