INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE

This INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE (this "Release") is made as of April 1, 2012 (the "Effective Date"), by Comerica Bank ("Comerica"), in favor of Verenum Corporation ("Verenum").

WHEREAS, pursuant to an intellectual property security agreement dated on or about October 19, 2011 and recorded in the U.S. Patent and Trademark Office under Reel and Frame 4645/0750 (the "Security Agreement"), Verenum granted a security interest in certain property, including, without limitation, the intellectual property identified on Schedule A attached hereto, to Comerica (the "Secured Obligations") owing by Verenum (such security interest, being the "Security Interest" and such intellectual property being the "Released Intellectual Property");

WHEREAS, the Secured Obligations have been paid and satisfied in full, and this Release is being executed to acknowledge and memorialize the release by Comerica of the Security Interest in the Released Intellectual Property.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Comerica agrees as follows:
