

3. Prior to the name change, the Company had filed and obtained federal service mark registrations for the following service marks (the "Registrations"):



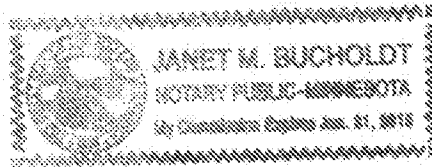
