TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Administrative Agent, on behalf of the holders of the Secured Obligations, and Grantor agree as follows:

- **SECTION 1.** <u>Defined Terms</u>. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notices.
- **SECTION 2.** <u>Termination and Release</u>. Administrative Agent, on behalf of the holders of the Secured Obligations, without representation, warranty, or recourse, hereby:
- (a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to, and under all the Trademarks, Trademark Licenses, and Proceeds of the foregoing, including the foregoing listed on Schedule A attached hereto; and
 - (b) authorizes the recordation of this Release with the USPTO.
- **SECTION 3.** Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of Michigan.
