**TERMINATION AND RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY RIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS ("Agreement"), dated as of June 8, 2012, from Wilmington Trust, National Association, as successor-by-merger to Wilmington Trust FSB, in its capacity as administrative agent ("Agent") for the Lender Group (as defined in the Credit Agreement, defined below), in favor of Holley Performance Products, Inc., Demon Fuel Systems, Inc. and Sniper Motorsports, Inc..

WITNESSETH:

WHEREAS, the Agent entered into that certain Credit Agreement, dated as of June 22, 2010 (as amended, modified and supplemented from time to time, the "Credit Agreement"), by and among Holley Performance Products Inc., a Delaware corporation (the "Administrative Borrower" or "Parent"), each of the Parent's direct and indirect subsidiaries party from time to time thereto and High Performance Industries, Inc., a Delaware corporation ("Parent Holdco"), then Agent and the lenders party thereto. Capitalized terms used herein without definition shall have the meanings assigned thereto in the Credit Agreement.

WHEREAS, pursuant to the Credit Agreement, the Administrative Borrower, certain Subsidiaries of the Administrative Borrower and the Agent are parties to certain Patent Security Agreements, dated as of June 22, 2010 and December 28, 2011, respectively (the "Patent Security Agreements"), pursuant to which the Administrative Borrower and such Subsidiaries granted a security interest in all of the Administrative Borrower's and such Subsidiaries' patents (including, without limitation, those items listed on Schedule A hereto, the "Patents"), to the Agent, for the benefit of the Lender Group which Patent Security Agreements were recorded with the United States Patent and Trademark Office on June 30, 2010 at Reel 024611/Frame 0530 and on January 6, 2012 at Reel 027490/Frame 0852, respectively;

WHEREAS, pursuant to the Credit Agreement, the Administrative Borrower, certain Subsidiaries of the Administrative Borrower and the Agent are parties to certain Trademark Security Agreements, dated as of June 22, 2010 and December 28, 2011, respectively (the "Trademark Security Agreements"), pursuant to which the Administrative Borrower and such Subsidiaries granted a security interest in all of the Administrative Borrower's and such Subsidiaries' trademarks (including, without limitation, those items listed on Schedule B hereto, the "Trademarks"), to the Agent, for the benefit of the Lender Group and which Trademark Security Agreements were recorded with the United States Patent and Trademark Office on June 30, 2010 at Reel 4234/Frame 0746 and on January 6, 2012 at Reel 4693/Frame 0379, respectively.

WHEREAS, pursuant to the Credit Agreement, the Administrative Borrower, certain Subsidiaries of the Administrative Borrower and the Agent are parties to that certain Copyright Security Agreement, dated as of June 22, 2010 (the "Copyright Security Agreement" together with the Patent Security Agreements and the Trademark Security Agreements, the "IP Collateral Agreements"), pursuant to which the Administrative Borrower and such Subsidiaries granted a

security interest in all of the Administrative Borrower's and such Subsidiaries' copyrights (including, without limitation, those items listed on Schedule C hereto, the "Copyrights" together with the Patents and the Trademarks, the "IP Collateral"), to the Agent, for the benefit of the Lender Group and which Copyright Security Agreement was recorded with the United States Copyright Office on July 2, 2010 at Volume 3592/Document 069.

WHEREAS, Administrative Borrower has paid all of the outstanding indebtedness to the Lender Group pursuant to which the Credit Agreement relates; and

WHEREAS, Administrative Borrower has requested that Agent release its security interest in the IP Collateral and reassign the same to Administrative Borrower and its Subsidiaries.

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the IP Collateral pursuant to the IP Collateral Documents, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Agent hereby states as follows:

1. Release of Security Interest. The Agent hereby unconditionally and expressly releases, terminates, and extinguishes any and all of its right, title and interest in and to any and all liens and security interests it may have upon the IP Collateral. This Release shall be binding upon the Agent's legal representatives, assigns and successors.


