**ASSIGNMENT AND RELEASE OF
SECURITY INTEREST**

June 20, 2012

This Assignment and Release of Security Interest (this "Release") is dated as of the date first set forth above. Reference is hereby made to that certain Trademark Security Agreement (the "Trademark Security Agreement"; capitalized terms used but not defined herein shall have the meanings given to them in the Trademark Security Agreement) dated as of November 3, 2010, by MegaPath Group, Inc. (formerly known as Covad Communications Group, Inc., a Delaware corporation and successor by merger to Laser Link.Net, Inc., a Delaware corporation, and Speakeasy Broadband Services, LLC, a Nevada limited liability company), a Delaware corporation ("MegaPath Group"), MegaPath Corporation (formerly known as DIECA Communications, Inc., a Virginia corporation and successor by merger to MegaPath Inc., a Delaware corporation, Covad Communications Company, a California corporation, DSLnet Communications VA, Inc., a Virginia corporation, and DSLnet Communications, LLC, a Delaware limited liability company), a Virginia corporation ("MegaPath"), MegaPath Holding Corporation (formerly known as CCGI Holding Corporation, a Delaware corporation), a Delaware corporation ("Holdings"), and NextWeb, Inc., a California corporation (together with MegaPath Group, MegaPath and Holdings, the "Pledgors"), in favor of Jefferies Finance LLC, a Delaware limited liability company, in its capacity as collateral agent pursuant to the Credit Agreement (in such capacity, the "Collateral Agent"), recorded with the United States Patent and Trademark Office on December 9, 2010, at Reel/Frame Nos. 4428/0391, 4428/0399, 4428/0411 and 4428/0515.


For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby notifies, acknowledges and agrees with each Pledgor that (i) the lien on and security interest in the Trademark Collateral pledged and granted by such Pledgor to the Collateral Agent for the ratable benefit of the Secured Parties pursuant to the Trademark Security Agreement, including, without limitation, the lien on and security interest in the trademarks listed on the attached Schedule A, are terminated, released and discharged fully, (ii) the Collateral Agent hereby releases and forever discharges fully all of its right, title and interest in, to and under, and of any kind or nature in the Trademark Collateral granted, assigned or conveyed pursuant to the Trademark Security Agreement, and (iii) any right, title or interest of the Collateral Agent in, to and under the Trademark Collateral shall hereby cease and become void. The Collateral Agent hereby retransfers and reassigns to each applicable Pledgor, without representation or warranty, all of the Collateral Agent's right, title and interest in, to and under the Trademark Collateral.

The Collateral Agent hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release.
