SECURITY INTEREST TERMINATION

WHEREAS, TRUBIQUITY, INC. (f/k/a AUTOWEB COMMUNICATIONS, INC.), a Michigan corporation (the "Grantor") granted a security interest to SILICON VALLEY BANK, a California-chartered bank with a principal place of business 3003 Tasman Drive, Santa Clara, California 95054 (the "Secured Party") in Grantor's trademark pursuant to that certain Confirmation of Intellectual Property Security Agreement dated August 7, 2007 which was filed at the United States Patent and Trademark Office on August 16, 2007, and recorded on Reel 003603, Frame 0427 ("Security Agreement"); and
