**PATENT AND TRADEMARK RELEASE**

THIS PATENT AND TRADEMARK RELEASE is effective as of March 9, 2012, by WELLS FARGO BANK, NATIONAL ASSOCIATION, as administrative agent (in such capacity, the "Agent") for the lenders party to that certain Credit Agreement dated as of August 15, 2011.

W I T N E S S E T H:

WHEREAS, the Agent and Rotonics Manufacturing Inc., a Delaware corporation ("Rotonics"), are parties to that certain Security Agreement dated as of January 26, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "Rotonics Security Agreement"), pursuant to which Rotonics granted a security interest to the Agent in substantially all of the personal property of Rotonics, including the Patents and Trademarks (as defined in the Rotonics Security Agreement), and specifically to the Patents and Trademarks set forth on Exhibit A hereto; and

WHEREAS, in conjunction with the security interest granted to the Agent under the Rotonics Security Agreement, the Agent and Rotonics entered into that certain Patent and Trademark Security Agreement, dated as of January 26, 2007 (together with all amendments, modifications and restatements of such agreement the "2007 IP Agreement"), recorded on January 29, 2007 with the United States Patent and Trademark Office at Reel 3470, Frame 0069 (with respect to trademarks) and Reel 018816, Frame 0213 (with respect to patents), pursuant to which Rotonics confirmed that it granted a security interest to the Agent in its Patents and Trademarks; and

WHEREAS, the Agent and Stratis Corporation, a Wisconsin corporation ("Stratis"), are parties to that certain Security Agreement dated as of August 23, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "Stratis Security Agreement"), pursuant to which Stratis granted a security interest to the Agent in substantially all of the personal property of Stratis, including the Patents and Trademarks (as defined in the Stratis Security Agreement), and specifically to the Patents and Trademarks set forth on Exhibit B hereto; and

WHEREAS, the Agent, Rotonics and Stratis entered into that certain Amended and Restated Patent and Trademark Security Agreement, dated as of November 20, 2008 (the "2008 IP Agreement"), recorded on November 21, 2008 with the United States Patent and Trademark Office at Reel 3891, Frame 0989 (with respect to Rotonics trademarks), Reel 3892, Frame 0001 (with respect to Stratis trademarks), Reel 021861 and Frame 0813 (with respect to Rotonics patents) and Reel 021861 and Frame 0933 (with respect to Stratis patents) pursuant to which Rotonics and Stratis reaffirmed and re-granted a security interest to the Agent in substantially all of their respective personal property, including the Patents and Trademarks; and

WHEREAS, the Agent and Rotonics entered into that certain Supplemental Patent Security Agreement, dated as of September 17, 2009 (the "2009 IP Agreement"), recorded on October 12, 2009 with the United States Patent and Trademark Office at Reel 023355, Frame 0532, pursuant to which Rotonics affirmed its grant of a security interest to the Agent in certain additional Patents; and

WHEREAS, the Agent and Rotonics entered into that certain Supplemental Patent Security Agreement, dated as of April 30, 2010 (the "2010 IP Agreement"), recorded on May 15, 2010 with the United States Patent and Trademark Office at Reel 024371, Frame 0923, pursuant to which Rotonics affirmed its grant of a security interest to the Agent in a certain additional Patent; and

WHEREAS, Synder Products, Inc. has requested that the Agent release its security interests in specific Patents and Trademarks subject to the Rotonics Security Agreement, the Stratis Security Agreement, the 2007 IP Agreement, the 2008 IP Agreement, the 2009 IP Agreement and the 2010 IP Agreement.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Agent hereby releases the security interests granted by Rotonics or Stratis under the Rotonics Security Agreement, the Stratis Security Agreement, the 2007 IP Agreement, the 2008 IP Agreement, the 2009 IP Agreement and the 2010 IP Agreement in all of the right, title and interest of Rotonics and Stratis in and to the specific Patents and Trademark registrations referred to in Exhibit A and Exhibit B annexed hereto (the "Specific Patent and Trademark Collateral"), and the goodwill of the business of Rotonics and Stratis connected with the use of and symbolized by the Specific Patent and Trademark Collateral.
