TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of July 20, 2012, and made by **U.S. BANK NATIONAL ASSOCIATION**, having an office at 555 SW Oak Street, Fl. 7, Portland, Oregon 97204 ("Grantee") to **HARMAR MOBILITY, LLC, HARMAR SUMMIT, LLC, HARMAR ACCESS, LLC** and **FREEDOM MOBILITY, LLC** ("Grantors").

WHEREAS, pursuant to that certain Security Agreement dated as of December 29, 2010, made by Grantors in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantors to Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on December 30, 2010, at Reel 4494 and Frame 0001 and February 18, 2011 at Reel 4483 and Frame 0415; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. The term "Trademarks," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates releases and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks.
