INTELLECTUAL PROPERTY SECURITY INTEREST ASSIGNMENT AGREEMENT

THIS INTELLECTUAL PROPERTY SECURITY INTEREST ASSIGNMENT AGREEMENT (this "Agreement") dated as of August 31, 2012 is by and among BANK OF AMERICA, N.A., as Administrative Agent, as successor by merger to LASALLE BANK NATIONAL ASSOCIATION ("Administrative Agent") under the Credit Agreement (defined below), BANK OF AMERICA, N.A., as Collateral Agent ("Collateral Agent") under the Intercreditor Agreement (defined below), KEMIN INDUSTRIES, INC., an Iowa corporation, KEMIN FOODS, L.C., an Iowa limited liability company, and KEMIN HOLDINGS, L.C., and KEMIN HOLDINGS, L.C., each a "Grantor", and collectively, the "Grantors").

WHEREAS, pursuant to the Second Amended and Restated Credit Agreement dated as of May 31, 2011 (which amended and restated that certain Amended and Restated Loan and Security Agreement dated as of August 13, 2004, as amended to date, and as the same may be further amended, restated, supplemented, or otherwise modified from time to time, the "Credit Agreement"), and the Security Agreement Summary dated as of August 18, 1999 ("Summary"), the Grant of Patent Security Interest dated as of May 31, 2011 ("Patent Grant"), and the Grant of Trademark Security Interest dated as of May 31, 2011 ("Trademark Grant") (Summary, Patent Grant, and Trademark Grant collectively the "Grants"), each among the Administrative Agent, the Grantors, and Lenders identified therein, the Grantors granted to the Administrative Agent a security interest in all of Grantors' right, title, and interest in and to the Collateral (as defined in the Summary), Patent Collateral and Trademark Collateral (collectively, the "IP Collateral"); and

WHEREAS, pursuant to that certain Note Purchase and Private Shelf Agreement dated as of August 31, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the "Senior Note Agreement") between Grantors on one hand, Prudential Investment Management, Inc. ("Prudential"), the Purchasers named on the Purchaser Schedule attached thereto and each other Prudential Affiliate (as therein defined) which may become a party thereto (individually, each a "Senior Noteholder" and collectively the "Senior Noteholders"), on the other hand, the Grantors have granted to the Collateral Agent, for the benefit of the Senior Noteholders, their rights, title and interest in and to the IP Collateral; and

WHEREAS, the Administrative Agent, the Collateral Agent, the Senior Noteholders and the Grantors are party to that certain Intercreditor and Collateral Agency Agreement dated as of August 31,2012 (as amended, restated, supplemented or otherwise modified from time to time, the "Intercreditor Agreement"); and

WHEREAS, Administrative Agent desires to assign its right, title, and interest in and to the IP Collateral to Collateral Agent for the benefit of the Benefited Parties, including the IP Collateral identified on Schedule 1 hereto.

- **NOW, THEREFORE**, in consideration of the mutual and dependent promises and undertakings set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, the parties hereto hereby covenant and agree as follows:
- 1. <u>Defined Terms</u>. Capitalized terms used herein and not defined herein shall have the meanings assigned to such terms in the Intercreditor Agreement and the Grants.

- 2. <u>Assignment</u>. The Administrative Agent irrevocably transfers, assigns, grants, and conveys to the Collateral Agent all of the Administrative Agent's right, title and interest in and to the IP Collateral, including, without limitation, the IP Collateral identified on <u>Schedule 1</u> hereto, the Grants, and all associated Liens, lien filings, and notices, together with any rider, addendum, exhibit, schedule, and attachment thereto.
- 3. <u>Representations and Warranties of Assignor</u>. This Agreement is an absolute assignment, and Assignor represents and warrants that (i) it has the requisite power and authority and the legal right to enter into this Agreement, and to perform its obligations hereunder and (ii) this Agreement has been duly executed and delivered on its behalf and is a legal and valid obligation binding upon it and is enforceable in accordance with its terms.
- 4. <u>Cooperation</u>. The Grantors, the Administrative Agent and the Collateral Agent shall cooperate with each other to effect the terms herein. Without limitation of the foregoing, (a) the Administrative Agent shall deliver to the Collateral Agent, on or promptly following the date hereof, the originals of this Agreement, (b) the Grantors and the Administrative Agent authorize the Collateral Agent to record this Agreement amending the name of the secured party to Bank of America, N.A., as Collateral Agent, and (c) the Grantors and the Administrative Agent agree to perform all reasonable and proper additional acts and to execute and deliver such further documentation as may be reasonably deemed necessary or desirable by the Collateral Agent to carry out the provisions and purposes of this Agreement and to preserve and perfect the liens and security interests.
- 5. <u>Successors and Assigns</u>. This Agreement is binding upon, and shall inure to the benefit of, the parties hereto and their respective successors and assigns.
- 6. <u>Expenses</u>. The Grantors agree to reimburse the Administrative Agent and the Collateral Agent for all reasonable out-of-pocket expenses (including reasonable fees and expenses of counsel) incurred in connection with this Agreement.
- 7. <u>Counterparts; Delivery</u>. This Agreement may be executed in any number of counterparts, each of which when so executed and delivered shall be deemed an original and it shall not be necessary in making proof of this Amendment to produce or account for more than one such counterpart. Delivery of an executed counterpart of this Agreement by facsimile or other electronic imaging means shall be effective as an original.
- 8. <u>Governing Law.</u> This Agreement shall be deemed to be a contract made under, and for all purposes shall be construed in accordance with, the laws of the State of Iowa.
