#### RELEASE OF TRADEMARK SECURITY INTEREST

This **RELEASE OF TRADEMARK SECURITY INTEREST** (this "Release") is made as of June 21, 2011 by **JPMORGAN CHASE BANK, N.A.**, in its capacity as collateral agent for the Secured Parties (as defined in the Credit Agreement) (in such capacity, the "Collateral Agent"), in favor of 19 Entertainment Limited and 19 TV Limited (the "Companies"). Capitalized terms used herein and not otherwise defined shall have the meaning set forth in the Trademark Security Agreement (as defined below) and if not therein defined, in the Guarantee and Collateral Agreement (as defined below).

### WITNESSETH

**WHEREAS**, the Collateral Agent, CKX, Inc., the agents and arrangers party thereto and the several banks and other financial institutions or entities from time to time party thereto as lenders are parties to the Amended and Restated Credit Agreement, dated as of April 15, 2011 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, pursuant to the Guarantee and Collateral Agreement, dated as of May 24, 2006 (as amended, restated, amended and restated, supplemented or otherwise modified from to time, the "Guarantee and Collateral Agreement"), each Company granted to Bear Stearns Corporate Lending, Inc. (the "Previous Agent"), for the benefit of the Secured Parties, a continuing security interest in and continuing lien upon certain property and assets of such Company, including all Trademarks owned by such Company;

WHEREAS, pursuant to the Guarantee and Collateral Agreement, each Company entered into the Trademark Security Agreement, dated as of May 24, 2006 (as amended by the Supplement No. 1 to the Trademark Security Agreement, dated as of April 15, 2011, the "<u>Trademark Security Supplement</u>" and as further amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "<u>Trademark Security Agreement</u>"), which Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 20, 2006 at Reel/Frame Nos. 3335/0145 and 3335/0135, and which Trademark Security Supplement was recorded with the United States Patent and Trademark Office on April 27, 2011 at Reel/Frame Nos. 4530/0037 and 4529/0771;

**WHEREAS,** pursuant to the Assignment and Assumption Agreement, dated as of April 15, 2011, which was recorded with the United States Patent and Trademark Office on April 27, 2011 at Reel/Frame No. 4529/0874, the Collateral Agent assumed all the interest in and to the Previous Agent's rights and obligations under the Trademark Security Agreement;

WHEREAS, CKX, Inc. has satisfied and paid in full all of its obligations under the Credit Agreement and the Collateral Agent as of the date hereof no longer has any right, title, or interest in, to and under any Trademarks of the Companies, including but not limited to the Trademarks and Trademark Licenses listed on Schedule A hereto (the "Trademark Collateral"); and

**WHEREAS**, the Companies have requested that the Collateral Agent release its security interest in the Trademark Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

The Collateral Agent hereby releases, transfers and assigns, without representation or warranty and without recourse, unto each Company, its security interest in all of such Company's right, title and

interest in, to and under the Trademark Collateral. The Collateral Agent hereby acknowledges and agrees that it has no further interests in the Trademark Collateral and that such Trademark Security Agreement is terminated and of no further force and effect.

The Collateral Agent authorizes the recordation of this Release with the United States Patent and Trademark Office and any other applicable registry or government office necessary to effect the release of its security interest in the Trademark Collateral.

This Release may be executed in any number of counterparts and by the parties hereto on separate counterparts, each of which when so executed, shall be deemed to be an original and all of which taken together shall constitute one and the same instrument.
