**TERMINATION AND RELEASE OF SECOND LIEN SECURITY
INTEREST IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS ("**Agreement**") dated as of October 2, 2012, from Wilmington Trust Company, as successor to Deutsche Bank National Trust Company as Collateral Agent (in such capacity, the "**Agent**") for the benefit of itself and the Noteholders, as defined in the Indenture.

WITNESSETH:

WHEREAS, K. Hovnanian Enterprises, Inc., a California corporation (the "**Issuer**"), Hovnanian Enterprises, Inc., a Delaware corporation, and each of the other Guarantors party thereto, entered into the Indenture dated as of May 27, 2008 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "**Indenture**") with Wilmington Trust Company (as successor to Deutsche Bank National Trust Company) as trustee, pursuant to which the Issuer issued 11 1/2 % Senior Secured Notes due 2013 (the "**Notes**") upon the terms and subject to the conditions set forth therein;

WHEREAS, in connection with the Indenture, the Issuer and each of the entities signatory thereto (the "**Grantors**") executed and delivered a Second Lien Security Agreement, dated as of May 27, 2008, in favor of the Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "**Security Agreement**");

WHEREAS, in connection with the Security Agreement, the Grantors executed and delivered an Intellectual Property Security Agreement, dated as of May 27, 2008 in favor of the Agent (the "**IP Security Agreement**"), pursuant to which a security interest (the "**Security Interest**") was granted by the Grantors to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined) as security for the obligations under the Indenture, the Notes and the other related documents;

WHEREAS, the IP Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on June 9, 2008, at Reel 003792 and Frame 0537; on December 1, 2009 at Reel 4105 and Frame 0759; and on December 1, 2009 at Reel 4105 and Frame 0721;

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the IP Security Agreement and the Security

Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Agent hereby states as follows:

1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including the preamble and recitals, have the meanings provided or provided by reference in the Indenture or in the Security Agreement, as applicable. The term "Trademark Collateral" as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademark registrations listed on Schedule A hereto.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest, liens and other encumbrances granted to or held by the Agent in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary or that any Grantor may reasonably request to effect the release of the Security Interest, liens and encumbrances contemplated hereby.
