TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (“Assignment”) is made and entered into as of this 29th day of June, 2012, (“Effective Date”), by and between **WAVELINK SOFTWARE LLC**, a Delaware limited liability company (“Assignor”), and **CRIMSON CORPORATION**, a Delaware corporation, (“Assignee”).

WHEREAS, Assignor wishes to enter into this Assignment to confirm that, effective as of the Effective Date, Assignee is the sole and exclusive owner of all worldwide right, title and interest in, to and under the trademark registrations and applications identified and set forth on Schedule A attached hereto and all goodwill associated therewith (collectively, the “Trademarks”).


NOW, THEREFORE, for good and valuable consideration, the receipt, adequacy and sufficiency of which are hereby acknowledged, Assignor hereby agrees as follows.

1. Assignor hereby irrevocably grants, conveys, assigns, transfers and sets over to Assignee, effective as of the Effective Date, free and clear of any and all liens and encumbrances, the entire right, title and interest in, to and under the Trademarks, together with the goodwill of the business associated therewith, for the United States and for all foreign countries and multi-national registration bodies, including, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations and all corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter arising or in effect, together with all rights to collect royalties, products and proceeds in connection with any of the foregoing and all rights to sue for past, present or future infringement, misappropriation, unfair competition, dilution or other violation of the foregoing, and all rights to recover damages or lost profits in connection therewith, and all rights corresponding thereto throughout the world.
2. Assignor hereby requests the Commissioner of Trademarks in the United States Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign countries or multinational authorities, to record Assignee as the assignee and owner of the Trademarks and to deliver to Assignee, and to Assignee’s attorneys, agents, successors or assigns, all official documents and communications as may be warranted by this Assignment.
3. This Assignment shall be governed by and construed in accordance with the laws of the State of Delaware, without giving effect to rules governing the conflict of laws.
4. Assignor shall, at Assignee's request, take all further actions, and provide Assignee, Assignee’s successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of all affidavits, declarations, oaths, exhibits, assignments, powers of attorney or other documentation) requested by Assignee to more fully and effectively effectuate the purposes of this Assignment.
5. This Assignment may be executed and delivered in one or more counterparts (including by means of facsimile or electronic delivery in portable document format), each such counterpart shall be deemed an original and all such counterparts shall constitute one and the same agreement.
