## RELEASE OF SECURITY INTEREST IN TRADEMARKS

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of October 9, 2012 ("Effective Date") by and between Wells Fargo Bank, National Association (as successor by merger to Wells Fargo Retail Finance, LLC), as agent for the Secured Parties (in such capacity, the "Administrative Agent"), and Collective Licensing International, LLC, Payless Shoesource Worldwide, Inc., Saucony, Inc., S.R. Holdings Inc., and SRL, Inc. (each a "Grantor" and, collectively, the "Grantors").

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement by and between Grantor and Administrative Agent dated August 17, 2007 (the "Trademark Security Agreement"), Grantor granted to Administrative Agent a continuing security interest in and to, and lien on, all of Grantor's right, title and interest in, to and under all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names owned by Grantor (collectively, the "Trademarks"), including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto, together with the goodwill associated therewith;

**WHEREAS**, Grantor and Administrative Agent entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Pledge and Security Agreement by and between Grantor and Administrative Agent dated August 17, 2007 (the "Security Agreement");

**WHEREAS**, the Trademark Security Agreement was recorded with the U.S. Patent and Trademark Office ("USPTO") both on November 8, 2007 at reel/frame number 3658/0767 and on February 11, 2008 at reel/frame number 3717/0034; and

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to Administrative Agent.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby terminates the Trademark Security Agreement and the Security Agreement, and hereby terminates, cancels and releases any and all security interests and liens it has in, to and on the Trademarks.


