INTELLECTUAL PROPERTY SECURITY AGREEMENT dated as of October 9, 2012 (this "*Agreement*"), among DEADLINE BUSINESS MEDIA, LLC, a Delaware limited liability company (the "*Borrower*"), the Subsidiary Guarantors (as defined in the Collateral Agreement referred to below) from time to time party hereto (together with the Borrower, the "*Grantors*") and THIRD POINT LOAN LLC, a Delaware limited liability company (the "*Lender*").

WHEREAS, the Grantors have entered into a Guarantee and Collateral Agreement, dated as of October 9, 2012 (as amended, supplemented or otherwise modified from time to time, the "*Collateral Agreement*"; capitalized terms used but not defined herein shall have the meanings assigned to such terms in the Collateral Agreement and, if not defined therein, in the Credit Agreement referred to in the Collateral Agreement), among the Grantors, the other Subsidiary Guarantors from time to time party thereto and the Lender.

WHEREAS, under the terms of the Collateral Agreement, the Grantors have granted to the Lender a security interest in, among other property, certain Intellectual Property of the Grantors and have agreed, as a condition thereof, to execute this Agreement for recording with the United States Patent and Trademark Office, the United States Copyright Office and other governmental authorities.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor agrees as follows:

SECTION 1. *Grant of Security*. Each Grantor hereby grants to the Lender a security interest in all of such Grantor's right, title and interest in or to the following Intellectual Property (the "*Collateral*"):

- (i) the patents set forth in Schedule A hereto;
- (ii) (A) the trademarks set forth in Schedule B hereto (*provided* that no security interest shall attach to any application for registration of a trademark or service mark with the United States Patent and Trademark Office (or any successor office) on an "intent to use" basis until such time as an amendment to allege use is submitted to and accepted by the United States Patent and Trademark Office (or any successor office), at which point the security interest shall automatically attach to such trademark or service mark), and (B) the goodwill associated therewith or symbolized thereby;
- (iii) the registered copyrights set forth in Schedule C hereto; and
- (iv) all proceeds of any and all of the foregoing.

SECTION 2. *Security for Obligations*. The grant of a security interest in the Collateral by each Grantor under this Agreement secures the payment or performance, as the case may be, of all Obligations of the Grantors now or hereafter existing under or in respect of the Loan Documents, whether direct or indirect, absolute or contingent, and whether for principal, reimbursement obligations, interest, premiums, penalties, fees, indemnifications, contract causes of action, costs, expenses or otherwise.

SECTION 3. *Recordation*. Each Grantor authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer record this Agreement.

SECTION 4. *Execution in Counterparts*. This Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

SECTION 5. *Grants, Rights and Remedies.* This Agreement has been entered into in conjunction with the provisions of the Collateral Agreement. Each Grantor does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of, the Lender with respect to the Collateral are more fully set forth in the Collateral Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein and, in the event of any conflict between this Agreement and the Collateral Agreement, the Collateral Agreement shall control.


SECTION 6. *Governing Law.* All issues and questions concerning the application, construction, validity, interpretation and enforcement of this Agreement or any other matter arising out of or in connection with this Agreement, the transactions contemplated hereby or the legal relationship among the parties hereto, whether in contract, tort or otherwise shall be governed by and construed in accordance with the internal Laws of the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction) that would cause the application of Laws of any jurisdiction other than those of the State of New York.

SECTION 7. *Collateral Agreement.* The provisions of Sections 8.11 and 8.13 of the Collateral Agreement are hereby incorporated into this Agreement, and each Grantor agrees that such provisions shall apply equally to this Agreement.




