GRANT OF TRADEMARK SECURITY INTEREST

THIS GRANT OF TRADEMARK SECURITY INTEREST (this "Agreement"), dated October 30, 2012 is by and between, Hines Growers, Inc., a Delaware corporation ("Grantor"), located at 2575 Olive Hill Road, Fallbrook, California 92028, and Wells Fargo Bank, National Association, as agent ("Agent") for the benefit of the Lenders (as defined in the hereinafter defined Loan Agreement). Each capitalized term utilized in this Agreement that is not defined in the Security Agreement (as hereinafter defined), the Loan Agreement (as hereinafter defined) or this Agreement, but is defined in the UCC, shall have the meaning set forth in Article 1, 8 or 9 of the UCC, as applicable.

WHEREAS, Grantor owns and uses in its business, and will, in the future adopt and so use, various intangible assets, including the Trademark Collateral (as defined below);

WHEREAS, Color Spot Nurseries, Inc., a Delaware corporation ("Borrower"), has entered into a Sixth Amended and Restated Loan and Security Agreement dated September 30, 2011 by and among Borrower, Agent and the Lenders from time to time party thereto (as amended, restated, modified or supplemented from time to time, the "Loan Agreement"), pursuant to which the Lenders have extended certain financial accommodations to Borrower;

WHEREAS, Grantor has executed and delivered that certain Fourth Amended and Restated Master Guaranty dated of even date herewith (as amended, restated modified or supplemented from time to time, the "Guaranty") and executed by Color Spot Holdings, Inc., a Delaware corporation ("Holdings"), Lone Star, Inc., a Delaware corporation ("LSI"), Lone Star Growers, L.P., a Delaware limited partnership ("Lone Star LP"), LSGR Holdings, Inc., a Delaware corporation ("Lone Star Holdings"), Powell Nurseries, Inc., a Delaware corporation ("Powell"), and Grantor (Grantor together with Holdings, LSI, Lone Star LP, Lone Star Holdings and Powell, each, a "Guarantor", and, collectively, "Guarantors"), in favor of Agent and the Lenders, pursuant to which Grantor has unconditionally guaranteed the Borrower's Obligations (as defined in the Guaranty); and

WHEREAS, pursuant to the terms of that certain Fifth Amended and Restated Master Security Agreement dated of even date herewith (as amended, restated modified or supplemented from time to time, "Security Agreement"), by and among Grantor and the other Guarantors, Grantor has granted to Agent a security interest in, and Agent has become a secured creditor with respect to, the Collateral specified therein, including the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, subject to the terms and conditions of the Security Agreement, to evidence further the security interest granted by Grantor to Agent pursuant to the Security Agreement, Grantor hereby grants to Agent a security interest in all of Grantor's right, title and interest in and to the following, in each case, whether now or hereafter existing or whether now owned or hereafter acquired and wherever the same may be located (the "Trademark Collateral"):

- (i) all trademarks, service marks, designs, logos, indicia, trade names, trade dress, corporate names, company names, business names, fictitious business names, trade styles and/or other source and/or business identifiers and applications pertaining thereto, owned by Grantor, or

hereafter adopted and used, in its business (including, without limitation, the trademarks set forth on Schedule A annexed hereto) (collectively, the “Trademarks”), all registrations that have been or may hereafter be issued or applied for thereon in the United States of America (“United States”) and any state thereof and in foreign countries (including, without limitation, the registrations and applications set forth on Schedule A annexed hereto), all common law and other rights (but in no event any of the obligations) in and to the Trademarks in the United States and any state thereof and in foreign countries, and all goodwill of Grantor’s business connected with the use of and symbolized by the Trademarks; and

- (ii) all Proceeds and Accessions with respect to any of the foregoing.

Notwithstanding anything herein to the contrary, in no event shall the “Collateral” include, and Grantor shall not be deemed to have granted a security interest in any of Grantor’s rights in or under, any United States intent-to-use trademark or service mark application to the extent that, and solely during the period prior to the filing of evidence of use of such trademark or service mark, the grant of a security interest therein would invalidate such intent-to-use trademark or service mark application under Federal law.

Grantor does hereby further acknowledge and affirm that this Agreement is made in connection with, and subject to the terms of, the Security Agreement and that the rights and remedies of Agent with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein, including, without limitation, subsection 7.11 (Governing Law; Consent to Forum). In the event of an irreconcilable conflict between the terms of this Agreement and the terms of the Security Agreement, the Security Agreement shall control.
