**IP SECURITY AGREEMENT**

**GRANT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS**

This GRANT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS, dated as of November 5, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the "IP Security Agreement"), is made by each of the signatories hereto (collectively, the "Grantors") in favor of Macquarie US Trading LLC, as collateral agent (together with its successors and assigns in such capacity, the "Collateral Agent") for the Secured Parties (as defined in the Credit Agreement referred to below).

WHEREAS, Amaya Gaming Holdings Canada, Inc., a Quebec corporation, ("Canadian Borrower"), Amaya Holdings Corporation, a Delaware corporation ("U.S. Borrower" and, together with Canadian Borrower, jointly and severally, the "Borrower"), have entered into a Credit Agreement, dated as of November 5, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), with the several banks and other financial institutions and entities from time to time party thereto and Macquarie US Trading LLC, as administrative agent and as collateral agent;

WHEREAS, it is a condition precedent to the obligation of the Lenders to make their respective extensions of credit to the Borrower under the Credit Agreement that the Grantors shall have executed and delivered that certain Guarantee and Collateral Agreement, dated as of November 5, 2012, in favor of the Collateral Agent (as amended, restated, supplemented or otherwise modified from time to time, the "Guarantee and Collateral Agreement"); and

WHEREAS, under the terms of the Guarantee and Collateral Agreement, the Grantors have granted a security interest in all Intellectual Property of the Grantors, including the IP Collateral (as defined below), to the Collateral Agent for the ratable benefit of the Secured Parties, and have agreed as a condition thereof to execute this IP Security Agreement for recording with the United States Patent and Trademark Office, the United States Copyright Office and any other similar Governmental Authority of any other country or political subdivision thereof, as applicable;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantors agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition have the meanings given to them in the Guarantee and Collateral Agreement.

SECTION 2. Grant of Security. Each Grantor hereby grants to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in and to, and continuing lien on, all of such Grantor's right, title and interest in and to the following, in each case, wherever the same may be located and whether now owned or existing or at any time hereafter acquired by such Grantor or in which such Grantor now has or at any time in the future may acquire any right, title or interest (collectively, the "IP Collateral"), as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of such Grantor's Obligations:

(a) all United States patents issued or assigned to and all patent applications and registrations made by the Grantors, including, without limitation, each patent and patent application identified in Schedule 1, as well as A) all rights and privileges arising under applicable law with respect to Grantors' use of any patents, B) all agreements (whether or not in writing) providing for the granting of any right to manufacture, use or sell any invention covered in whole or in part by any Patents, whether Grantor is licensee or licensor thereunder, C) all provisionals, reissues, divisions, continuations, continuations-in-part, extensions, renewals, and reexaminations thereof, and D) all inventions and improvements described and claimed therein;

(b) (i) all United States trademarks, service marks, trade names, corporate names, company names, business names, trade dress, fictitious business names, trade styles, logos, or other indicia of origin or source or business identification, trademark and service mark registrations and recordings, and applications for trademark or service mark registrations and any renewals thereof, including, without limitation, each registration and application identified in Schedule 1, along with the goodwill of the business connected with the use of, and symbolized by, each of the above; *provided, however*, that notwithstanding anything herein to the contrary, in no event shall the security interest granted hereunder attach to any "intent-to-use" application for registration of a trademark filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, prior to the filing of a "Statement of Use" pursuant to Section 1(d) of the Lanham Act or an "Amendment to Allege Use" pursuant to Section 1(c) of the Lanham Act, solely to the extent, if any, and solely during the period, if any, in which the grant of a security interest therein would void said application or impair the validity or enforceability of any registration issuing therefrom;

(c) (i) all United States copyrights, whether registered or unregistered and whether or not the underlying works of authorship have been published, including but not limited to copyrights in software and databases, all Mask Works (as defined in 17 U.S.C. 901 of the U.S. Copyright Act), all right, title and interest to make and exploit all derivative works based on or adopted from works covered by such copyrights, and all copyright registrations, and copyright registration applications, supplemental registrations, and any renewals, extensions or rights to obtain renewals thereof, including, without limitation, each registration and application identified in Schedule 1, and (ii) the rights to print, publish and distribute any of the foregoing (collectively, "Copyrights");

(d) all exclusive licenses to Copyrights, Patents or Trademarks owned by third parties and registered with the United States Copyright Office;

(e) all internet domain names identified on Schedule 1;

(f) the right to sue or otherwise recover for any and all past, present and future infringements, dilutions and other violations of any of the foregoing;

(g) all income, royalties, damages and other payments now and hereafter due and/or payable with respect to any of the foregoing; and

(h) all other rights of any kind whatsoever accruing thereunder or pertaining thereto.



Notwithstanding anything to the contrary in this IP Security Agreement, no Excluded Assets shall constitute IP Collateral

SECTION 3. Recordation. Each Grantor authorizes and requests that the Register of Copyrights and/or the Commissioner of Patents and Trademarks (as applicable) and any other applicable government officer record this IP Security Agreement.

SECTION 4. Execution in Counterparts. This IP Security Agreement may be executed by one or more of the parties to this IP Security Agreement on any number of separate counterparts (including by telecopy), each of which when so executed shall be deemed to be an original and all of said counterparts taken together shall be deemed to constitute one and the same instrument. Delivery of an executed signature page of this IP Security Agreement by facsimile or electronic transmission shall be effective as delivery of a manually executed counterpart hereof.

SECTION 5. Governing Law. This IP Security Agreement and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York without regard to conflict of law principles that would result in the application of any law other than the law of the State of New York.


SECTION 6. Conflict Provision. This IP Security Agreement has been entered into in conjunction with the provisions of the Guarantee and Collateral Agreement and the Credit Agreement. The rights and remedies of each party hereto with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Guarantee and Collateral Agreement and the Credit Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this IP Security Agreement are in conflict with the Guarantee and Collateral Agreement or the Credit Agreement, the provisions of the Guarantee and Collateral Agreement or the Credit Agreement shall govern.

SECTION 7. Grantor Remains Liable. Each Grantor hereby agrees that, anything herein to the contrary notwithstanding, such Grantor shall assume full and complete responsibility for the prosecution, defense, enforcement or any necessary actions in connection with the IP Collateral subject to the rights of the Secured Parties and the Collateral Agent exercised upon Event of Default.
