ASSIGNMENT OF GRANT OF SECURITY INTEREST IN UNITED STATES INTELLECTUAL PROPERTY

WITNESSETH:

WHEREAS, reference is made to (i) that certain Amended and Restated Credit Agreement, dated as of February 18, 2010 (as amended, restated, supplemented or otherwise modified and in effect from time to time, the "Credit Agreement"), by, among others, Michaels Stores, Inc. (the "Lead Borrower"), the other Borrowers (together with the Lead Borrowers, collectively, the "Borrowers"), the Facility Guarantors (the Borrowers and the Facility Guarantors are hereinafter referred to as the "Loan Parties"), the Lenders party thereto from time to time, and Bank of America, N.A., as Administrative Agent and Collateral Agent (in such capacities, the "Existing Agent"), Swingline Lender and Issuing Bank; and (ii) (A) that certain Grant of Security in United States Trademarks dated as of October 30, 2006 by and between Michaels Stores Procurement Company, Inc., as Grantor (the "Grantor"), and the Existing Agent, which was recorded with the U.S. Patent and Trademark Office on November 9, 2006, at Reel 3424, Frame 0949, (B) that certain Grant of Security in United States Trademarks dated as of May 1, 2009 by and between the Grantor and the Existing Agent, which was recorded with the U.S. Patent and Trademark Office on January 12, 2010, at Reel 4130, Frame 0154, (C) that certain Grant of Security in United States Trademarks dated as of February 18, 2010 by and between the Grantor and the Existing Agent, which was recorded with the U.S. Patent and Trademark Office on March 3, 2010, at Reel 4160, Frame 0391, (D) and that certain Grant of Security in United States Trademarks dated as of March 25, 2012 by and between the Grantor and the Existing Agent, which was recorded with the U.S. Patent and Trademark Office on May 18, 2012, at Reel 4783, Frame 0558 (as amended, restated, supplemented or otherwise modified and in effect from time to time, collectively, the "Existing Intellectual Property Security Agreements" and, together with the Credit Agreement, the "Existing Agreements").

WHEREAS, pursuant to the Existing Agreements, the Grantor granted to the Existing Agent a security interest in, among other things, the Trademarks (as defined herein).

WHEREAS, effective as of the date hereof, the Existing Agent has resigned as Administrative Agent and Collateral Agent in accordance with the terms of the Credit Agreement.

WHEREAS, effective as of the date hereof, Wells Fargo Bank, 'National Association ("Wells Fargo") has been appointed successor Administrative Agent and Collateral Agent (in such capacities, the "New Agent") in accordance with the terms of the Credit Agreement.

WHEREAS, reference is further made to that certain Second Amended and Restated Credit Agreement, dated as of September 17, 2012, by and between, among others, the Loan Parties and the New Agent.

NOW, THEREFORE, the Existing Agent hereby transfers, conveys, assigns, and delivers all of its right, title and interest in the Existing Intellectual Property Security Agreements to the New Agent, together with any lien and security interest which was granted to the Existing Agent pursuant to the Existing Agreements in those trademarks, service marks, applications for

trademarks or service marks owned by the Grantor and identified in <u>Schedule A</u> attached hereto (as further defined in the Existing Intellectual Property Security Agreements, the "<u>Trademarks</u>").

To all whom it may concern be it known that for, and in consideration of, said agreements and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Existing Agent has transferred, conveyed, assigned and delivered and by these presents does hereby transfer, convey, assign and deliver unto the New Agent, its successors, assigns, and legal representatives, the Existing Agent's entire right, title and interest in and to the Trademarks, throughout the United States of America, its territories and all foreign countries, together with any and all goodwill related thereto.

The Existing Agent agrees that, upon request of the Grantor or the New Agent, and at the Grantor's sole expense, the Existing Agent will execute any document, cause to be made any filing or take any other action deemed reasonably necessary or advisable by the New Agent to effectuate the assignment of interests contemplated herein.
