 - (b) represents and warrants that it has full authority to execute and deliver this Release; and
 - (c) authorizes the recordation of this Release with the USPTO at Grantor's expense.
- SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
